## PARENT AGREEMENT

I will pay a monthly tuition fee of: \_\_\_\_\_ for my child. Payment is due in advance no later the 5<sup>th</sup> of every month. If tuition is not paid on time, a penalty of \$25.00 late fee will be added. The discounted rate (for children over 18 months) of \*\$385 is applicable only for monthly payments made in full before the 5<sup>th</sup> of the month; otherwise, the fee of \$400 is applicable plus late fees, regardless of circumstances as these are the pay periods for the caregivers. **Please note that tuition will not be discounted for any absences occurred for children who are enrolled in the Center.** If tuition is not paid on time, a penalty of \$25.00 will be added for both pay periods in a month, totaling to \$50.00 (before the 5<sup>th</sup> of the month; before the 20<sup>th</sup> of the month).

\* Parents must notify front desk when your child is eligible for 18 months tuition discount (\$385). Reimbursements will not be made for prior payments made before notification of discount.

My child will be in care between the hours of 7:15 am and 6:00 pm Monday through Friday. Care outside of these hours will require an additional fee of \$1.00 per minute until child(ren) are picked up, which is to be paid the same day.

If I withdraw my child(ren) from care, I will notify Vivace Music Academy and Learning Center LLC within (2)two weeks in advance, before the end of the month; otherwise, a penalty of \$50 will be incurred. **All fees and supplies are non-reimbursable for withdrawals.**

Enrollment and tuition is accepted at a full monthly basis only, unless otherwise arranged with Ms Luna. **Please note that Drop-In rates for children who are not enrolled for the entire month (payment is not for the entire month) are considered withdrawn and are charged at a higher daily rate (\$25 per day) than those children who are enrolled for the entire month. As we are counting on tuition payments to pay our caregivers, please be courteous enough to let Ms. Luna know of any intentions of future withdrawals within (2)two weeks in advance, before the end of the month; otherwise, a penalty of \$50 will be incurred. This notice includes winter and summer months. All fees and supplies are non-reimbursable for withdrawals.**
