

Club Rules:

Updated 1/8/25

1. All members are required to be good sportsman. Any member violating CLUB and/or STATE GAME LAWS on club property are subject to a fine or dismissal from club without refund of dues.
2. All members must give name and show membership card when questioned by a fellow member.
3. All members are responsible to keep the club free of litter clean.
4. All gates must be CLOSED and LOCKED upon entering and leaving the hunting lease.
5. No grain of any type is allowed on lease from March 1st through the last day of Turkey season.
6. Member's immediate family is not required to pay dues until the age 18. A family member in the military FULL time or FULL time college student does NOT have to pay dues until the age 23.
7. Members can bring hunting guest up to the age of 16 provided that their hunter safety course has been complete. The guest must be in members presence at all times. THIS RULE APPLIES TO THE YOUTH HUNT AS WELL ONLY 16 AND UNDER CAN PARTICIPATE IN THE YOUTH HUNT.
8. No adult guest is allowed during daylight hunting hours. Members are allowed one adult guest with NO HUNTING TO KILL. Guest must ride in same vehicle as member.
9. All elected board members is for a 3 year term.
10. All complaints Must be filed with board within 90 days of occurrence.
11. NO DESTROYING OR CUTTING OF ANY PINE TREES on hunting lease.
12. No alcohol allowed during daylight hunting hours.
13. Members who are remaining in the club for the following season required to pay 50% of club dues by 14. Feb. 1st witch is NON REFUNDABLE. You may also pay full price at this time. Any member that does not pay 50% of club dues must pay NEW MEMBER DUES BY April 30th ALL MEMBERS MUST PAY IN PERSON TO FILL OUT MEMBERSHIP CONTRACT. OR YOU CAN GO TO www.mosshillhuntingclub.com TO PRINT CONTRACT OUT AND MAIL WITH YOUR PAYMENT TO P.O BOX 21 PEARL RIVER LA. 70452 OR YOU MAY ALSO PAY ONLINE. IF YOU PAY ONLINE YOU MUST PRINT OUT CONTRACT AND FILL OUT AND SIGN IT AND EMAIL OR MAIL IT TO US. FAILURE TO DO SO COULD RESULT IN YOUR PAYMENT BEING SENT BACK TO YOU. IF THIS WERE TO HAPPEN YOU WILL BE CONTACTED BY THE BOARD FIRST AND YOU COULD LOSE YOUR SPOT IN LINE TO A PAYING MEMBER IF WE DON'T RECEIVE YOUR PAID MEMBERSHIP APPLICATION.
- 15. ALL members are required to make two work days per year one in June and one in Sept. or pay \$150.00 fine per workday!!! If you are making up workdays the deadline to make up each workday will be 30 days after the work day has taken place or pay the \$150.00 fine per workday missed. All members will be assigned a work foreman. The list will be posted at the clubhouse or online at www.mosshillhuntingclub.com The Member MUST contact the work foreman if not able to make the original workday. If member does not make up the workdays the member will be sent an invoice by Dec. 1st and will be due on Jan 1st. Or contacted by a board member or treasurer of the hunting club for the workday the member did not make up that we had in June and Sept. You can mail your Check to P.O box 21 Pearl River La 70452.**
16. All members must follow all state hunting laws each year. For the season state law says one buck one Doe and one either. Club Members are allowed to kill one Doe one buck and one either ,which may be harvested according to Louisiana State Deer season. Bucks MUST BE 3 POINT ON ONE SIDE OR BETTER AND ALL DOES MUST BE 60 LBS OR GRATER!!!!!!!!!!!!!!!!!!!!!!!!!!!!
17. Any Paying member that brings immediate family or guest is allowed five total deer of witch only two can be does.
- 18 Does can be killed till the end of January of 2025.**
19. All members are required to log in all deer killed on lease at club house the day of kill NO EXCEPTIONS!!!!!!!!!!!!
20. If a member shoots a deer that is NOT 3 point on one side or better or a Doe that is less than 60LBS. Will pay a \$100.00 fine NO EXCEPTIONS!!!!!!!!!!!!
21. The Mossy Hill Hunting Club calendar year will run from March 1st to March 1st
- 22. When a member sponsoring a child for youth hunt, if the child kills a deer it will count as one of the members deer.**
- 23. If a member shoots they have to call their work foreman and let him know. if he kills he has to send a picture to his foreman. That includes hogs, bobcats, are what even. All deer killed must be weighted and wore on the board at the club house, on day of kill. Failure to do so, will result in a fine of \$100.00 for first offence, a \$200.00 for second offense, and 3rd offense are out of the Club.**
