## Janice's Journal: A Small, But Significant Victory

Marion County, Arkansas, posted signs on the front door of registrants last year identifying those individuals as people required to register as a sex offender. The signs stayed in place not for one day, but for about two weeks – a week before Halloween, Halloween and then a week after Halloween.

This Halloween sign requirement was not a state law. In fact, it was not a county law. Instead, it was a decision by a county sheriff who printed signs with his name on it.

Implementation of the Halloween sign requirement in Marion County was different than Halloween sign requirements in most locations. In most locations, registrants were required to create a sign and then post it on their home. In Marion County, however, the signs were created by the government and then posted by the government on the front door of people's homes.

When a deputy sheriff arrived to post a Halloween sign on the front door of the plaintiff's home, he objected to the sign and asserted that his First Amendment rights would be violated by that sign. The deputy sheriff flippantly stated, if you don't like the sign, then sue us.

Fortunately, that's exactly what the plaintiff did. He called ACSOL and asked that a lawsuit be filed challenging the Halloween sign requirement.

After the lawsuit was filed in federal court, the attorney representing the sheriff's office argued to the judge that the posting of the Halloween sign was voluntary. The judge's reply is one to be remembered. He asked if posting a sign is voluntary when the person posting it is wearing both a gun and a badge.

Shortly after that hearing, Marion County decided to settle the case. In a written agreement, that county has stated they will no longer require registrants in Marion County to have a Halloween sign posted on their residence.

Given that there are only 65 registrants in Marion County, this is a small victory. It is a significant victory, however, because there are other counties in Arkansas as well as cities in other states that require Halloween signs. Those counties and cities now have a choice – stop requiring Halloween signs to be posted on the homes of registrants or be sued in federal court.

Up to 32,000 people could be added to the California registry if Senate Bill 1128 is enacted into law, according to the California Department of Justice. That is because the bill would require individuals convicted of Penal Code Section 261.5, unlawful sexual intercourse with a minor, to register if the age gap was 10 years or more.

Currently individuals convicted of PC 261.5, unlawful sexual intercourse with a minor are not required to register regardless of the age gap. If enacted into

law, the bill would be applied retroactively.

"If this bill is enacted into law, individuals convicted decades ago could be required to register for the first time," stated ACSOL Executive Director Janice Bellucci. "Therefore, we must stop Senate Bill 1128 as soon as possible."

According to the California Sex Offender Management Board (CASOMB), there would be a "significant cost" to state and local governments if SB 1128 became law. The bill would also unwind the stated purpose of the Tiered Registry Law, according to one CASOMB member. That purpose was to reduce what was previously considered a bloated state registry. Another CASOMB member added that passage of SB 1128 would set 32,000 people "up to fail" and make their lives as unstable as possible due to housing and employment challenges.

The co-authors of Senate Bill 1128 are Senator Anthony Portantino of the San Fernando Valley and Assemblymember Blanca Rubio of West Covina. Both legislators are Democrats. SB 1128 was introduced on February 13 and the Senate passed the bill on May 23. Senator Scott Wiener, author of the Tiered Registry Bill, voted against SB 1128 both during a Senate Public Safety committee hearing and on the floor of the Senate.

SB 1128 has been referred to the Assembly Public Safety Committee which will next consider the bill. That Committee, however, has not yet set a hearing date.

"We must oppose Senate Bill 1128 in order to prevent the addition of more than 30,000 people to the registry," stated Bellucci. "ACSOL leaders will soon prepare a strategy to stop this bill and that information will be shared on this website as well as sent by email and text."

Members of the California Sex Offender Management Board discussed SB 1128 during its meeting today. The Board plans to issue a point paper regarding possible impacts of the bill upon individuals convicted of PC 261.5 as well as state and local governments.

#### America Criminalizes Too Much and Punishes Too Much

When those on parole or probation are included, one out of every 47 adults is under "some form of correctional supervision."

Not only have we adopted more criminal laws at an astonishing clip, but the punishments our criminal laws carry have also grown markedly. Beginning in earnest in the second half of the 20th century, legislatures began to adopt laws that had, as Judge Jed Rakoff has noted, "two common characteristics: they imposed higher penalties, and they removed much of judicial dis-cretion in sentencing." Notable among these laws were statutes imposing mandatory minimum terms of imprisonment for certain crimes.

Today, sentencing changes like these can propel some sentences into the stratosphere. A defense attorney in Florida told The Economist that, looking at his clients' prison terms, it appeared to him

that the United States was conducting "an experiment in imprisoning firsttime non-violent offenders for periods of time previously reserved only for those who had killed someone." One of his clients who had been convicted of fraud was sentenced to 845 years. "I got it reduced to 835," the lawyer said with a sigh. A group that looked across state prison systems found "a consistent upward trend in the amount of time people spend in state prisons" and that the "longest prison terms are getting longer." Another group found that one out of every seven of those now incarcerated is serving a life sentence—more people in total than were serving any sentence in 1970. And while crime tends to be a "young man's game," 30 percent of those serving life sentences were found to be over the age of 55.

Thanks to developments like these, the United States is now a world leader when it comes to incarceration. Our incarceration rate is not only eight times as high as the median rate in western European democracies, it is higher than the rates found even in Turkmenistan and Rwanda. As in those of many states, federal prisons have been operating for years around or above 100 percent capacity. And those who emerge from our prisons often confront collateral consequences that haunt them for years—including the loss of voting rights, licenses, public benefits, jobs, and access to housing.
