## What's behind the recent uptick in local child predator arrests?

PORT ST. LUCIE, Fla. (CBS12) — This week, we have seen an alarming number of child predators arrested.

Is that because there are more cases out there, or is law enforcement getting better at catching these criminals?

Indian River County Sheriff Eric Flowers credits that success largely to social media sites and app developers, that are helping to weed out bad actors.

"A lot of these platforms have really complied, not just with our requests for subpoenas, but really been somewhat voluntary with us," he told CBS12 News. "These companies have worked with the National Center for Missing and Exploited Children to provide information tips are leading us directly to the perpetrators."

Callahan Walsh at the National Center for Missing and Exploited Children (NCMEC) says those tips are vital to cracking cases, and he says reporting is happening more than ever.

"I think what's behind increase in the busts is great reporting and great action taken by law enforcement...the reporting systems are better, social media platforms are making it easier for people to report," Walsh opined. "Last year, we received over 36 million reports to our CyberTipline, and we've already seen numbers surpass that this year."

In St. Lucie County, deputies arrested a man this week for possessing child porn.

An employee at T-Mobile tipped off the sheriff's office, after he saw the disturbing images on the suspect's phone.

Sheriff Keith Pearson says observant communities are crucial to catching these criminals.

"See something, say something," he said. "(it) helps us to be able to identify these sick people, and get them out of our community."

Its not only people speaking up that's making a difference, but also teaching children about online safety.

"We believe prevention is working, kids are becoming more savvy would-be predators (are) trying to prey on children, and kids saying 'no,' Walsh explained. "This is why online safety has to be a conversation that we're all having with your kids."



### Sex offenders suing New Mexico sheriffs, DPS

ALBUQUERQUE, NM (KRQE) – More than a half dozen sex offenders who committed their crimes in other states say they're being treated unfairly in New Mexico.

Now, eight out-of-state sex offenders now living in New Mexico, calling themselves John Does, are suing the Department of Public Safety and various sheriffs to get their fair shot at a hearing.

"When someone moves to New Mexico, they're kind of automatically by default required to register," Liberty and Justice Coalition Attorney Barett G. Porter said.

Porter said many convicted sex offenders who move to New Mexico aren't getting the state-required case review to determine if they should even have to register as a sex offender.

"We're not actually looking for a break," Liberty and Justice Coalition Attorney Ashley Reymore-Cloud stated. "What we're looking for is that they're awarded their constitutional due rights and due process that every single person is entitled to regardless of what they did."

The lawsuit states that registering as a sex offender in New Mexico entails "significant burdens."

"[They are required to] report to the sheriff every 90 days; tell your employer that you're a registered sex offender; provide all of your information about your vehicle; and be published on the internet, all when, in fact, you may not even need to register in this state," Porter said.

In one example, the lawsuit said one of the John Does was convicted of sexual assault and only had a 10-year registration period in Colorado but has to register for life in New Mexico.

Porter said the lawsuit is not about challenging the sex offender registration rules but getting their day in court.

"A court should do this analysis. You look at the plea documents, you look at the judgment and maybe even have to

reach back to the police reports to find out, you know, what are the elements of this offense that equate to a sex offense in New Mexico?" Porter explained.

Porter referred to the DPS website, which states there are still about 1,000 sex offenders waiting for their out-of-state cases to be reviewed.

In response to the lawsuit, DPS said it's processed 323 out-of-state cases since February.

Five New Mexico sheriffs are named in the lawsuit because they maintain the sex offender registries for the counties where the John Does live.

The Bernalillo County Sheriff's Office would not comment on the pending litigation but said it is committed to keeping families and businesses safe.

# NARSOL's new case fights for parolees' rights to bring civil rights challenges over parole conditions By Mark

. NARSOL announces the filing of its opening appellate brief in the Seventh Circuit Court of Appeals in the case NARSOL et. al. v. Latoya Hughes, No. 24-2103. NARSOL is the lead plaintiff in the case. The case involves a challenge to the constitutionality of a parole restriction imposed on individuals on mandatory supervised release in Illinois for a sexual offense. In particular, plaintiffs sued the Director of the Illinois Department of Corrections seeking injunctive relief from the prohibition on individuals using erectile dysfunction medication while on mandatory supervised release. Plaintiffs contend that the condition interferes with rights protected by the Fourteenth Amendment's substantive due process component and the Eighth Amendment's prohibition on cruel and unusual punishment.

At its core, however, the case is not

about the particular condition being challenged. It is about the ability of individuals on parole as a general matter to challenge the constitutionality of their parole conditions through the civil rights law (I.e., § 1983) as opposed to being forced to challenge these conditions through a habeas corpus petition. As things currently stand, individuals may only challenge the constitutionality of their parole conditions via a habeas petition, which has the realworld effect of foreclosing individuals' ability to challenge the constitutionality of their parole conditions at all given the burdensome requirements associated with bringing a habeas challenge and given that attorneys' fees are not recoverable in such an action. This mean that the cases, when they are brought at all, are brought pro se (on one's own behalf, i.e., selfrepresentation).

The lawsuit is important primarily

because parole conditions have over time become increasingly intrusive and harsh. Many conditions now are categorically imposed by statute, without any individualized consideration, and intrude upon an individual's most basic constitutional rights. They include wholesale internet restrictions, inhumane nochild-contact restrictions, and burdensome GPS requirements. Absent the ability of individuals to effectively challenge such restrictions via § 1983, individuals are forced to endure constitutionally suspect conditions for years while on criminal supervision.
