### GUEST SPEAKER



Mark Whiting, is the Program Manager of Virginia Department of Veterans Services, Military Medics and Corpsmen (MMAC) program.

With a career spanning the public, private and non-profit sectors, Mark brings a unique perspective to his role as Program Manager for the Virginia Department of Veteran Services (DVS), Military Medics and Corpsmen Program. Prior to serving at DVS Mark was Healthcare Industry Sector Coordinator for the Virginia Employment Commission. At VEC Mark facilitated the hiring of veterans, Transitioning

Service Members and their spouses at healthcare employers statewide.

Mark first entered state government as a paid intern with the Virginia Department of Health, Office of Emergency Medical Services (OEMS) during his senior year at Virginia Commonwealth University's School of Mass Communications. There he wrote the nation's first book on media and public relations for first responder organizations. That internship led to a 10-year career as Public Information Officer for the OEMS.

Mark left OEMS to form River's Edge Productions, Inc., a video and television production firm serving clients nationwide. His creative work has been recognized by awards from the International Television Associa-



tion, the National Association of Government Communicators, International Association of Business Communicators, Public Relations Society of America and Crime Solvers International. He is the recipient of four TELLY © Awards.

Mark's work in the non-profit field included serving 9 years with the American Red Cross as Director of the Red Cross Center for Community and Corporate Education, as Regional Director of Communications and then with the National Office of the Red Cross as Senior Program Manager. In that role he managed Certified Nurse Assistant and Allied Health Training Programs in 5 Mid-Atlantic states.

The son of a World War II Army Combat Medic, Mark started in public safety and healthcare as a Paramedic and Firefighter for the City of Lynchburg, Virginia.

An innovative and award-winning program, the Military Medics and Corpsmen Program (MMAC) at the Virginia Department of Veterans Services is changing the way healthcare hires veterans in Virginia. MMAC facilitates veteran hiring in clinical, non-clinical and leadership positions by recruiting, reviewing and referring candidates to healthcare employers statewide. As the first and only program of its type in the nation, the MMAC-Qualified Pathway serves recently discharged veterans who were Army Medics, Navy/Coast Guard Corpsmen or Air Force Medical Technicians. MMAC has Memos of Agreement with 10 major healthcare systems across the Commonwealth (including Sentara, Bon Secours, Riverside and Chesapeake Regional) to allow MMAC-Qualified employees to apply their extensive clinical skills and experience under supervision while they obtain required civilian clinical credentials.

As many of you may remember, Jaime Areizaga-Soto, Deputy Secretary of Virginia Veterans Affairs, was our speaker at the January 2016 meeting and mentioned this program. Passing legislation for establishing a pilot program for MMAC was one of the JLC 2016 Initiatives. The program passed the Virginia

Legislative Session and Governor McAuliffe signed the bill for the pilot program at Sentara Norfolk General Hospital on 27 June 2016. Sherry Ferki, Karl Wilson and Steve Turner attended this historic event.

In the past, the major objective was only to support the troops but now the whole family is supported. There is always a need for volunteers as well as for donations. There are 17 staff and about 1500 volunteers currently for the many ongoing activities supported by the HRCV USO. As a pediatric nurse, one of the programs caught my eye - Little Patriots Trunk Hop on Saturday 13 April in Virginia Beach. ### PACMOAA SCHOLARSHIP FUND UPDATE

Since I took the chair, now co-chair, of the Scholarship committee in 2001, PACMOAA has awarded 32 scholarships, 28 of which were paid. One student failed his school ROTC physical, two students dropped out of school shortly after the first semester started, and one of the awardees had family issues and was not able to attend college.

One to three scholarships have been awarded each year, ranging from \$1000 to \$2000. The scholarship is awarded over the first two semesters in school and is contingent upon continued enrollment in ROTC. The money may be used for tuition purposes, room and board, and other school related expenses. *Unlike the MOAA scholarships, the students do not have to come from a military family.*

Information pertaining to this scholarship will be going out to local high schools in Portsmouth, Suffolk, Franklin, Chesapeake, Southampton and Isle of Wight this month. That includes over 30 local high schools in addition to 13 JROTC units. CDR Scott Dickinson, the Co-Chair of the Scholarship Committee revised the application so that it can be filled out electronically including an electronic scoring sheet for the PACMOAA Scholarship Committee members to facilitate a better review of applications. Scott also emailed the scholar-

ship information to the local high schools and his assistance is greatly appreciated!

The number of scholarships to be awarded for the year is voted on by the Leadership Team and is based on donations from PACMOAA members. We would like to award at least 2 scholarships if members donate enough.

College expenses are increasing as are all other expenses. Please consider a donation to help these students in their quest for a career in the military. It was brought to my attention that I neglected to remind everyone about contributing to the scholarship fund when discussing sending in your dues - thank you Jack Lyons! That is usually when we receive most of the money contributed to the scholarships. You could also add \$5 or \$10 to your dinner check. All donations are greatly appreciated and most helpful! Thank you for your generous support over the years which has made our program so successful!

The scholarship winners and their parents will attend the June PACMOAA dinner meeting and be recognized there. It is always a pleasure to meet them and hear of their accomplishments in school as well as their goals.

### **CHAPLAIN'S CORNER**

#### **LOVE, THE GREATEST COMPLIMENT**

My small unit was one of the very first to arrive in Sarajevo after the signing of the Dayton Peace Accords. A day or two after our arrival, I began making the rounds, visiting other units in and around the city.

One of the American communications outfits I went to see had set up in an old Ottoman fort high on the mountaintop overlooking the city. The road to the fort was a long a mountain

path, barely passable in our humvee. At one point, the road squeezed between a sheer vertical drop on the left and a small village on the right. Absolutely pressed against the road, the tiny community was wedged into the minuscule space between the path and the wall of the mountain.

I was riding in the front side passenger seat of the humvee with my arm out of the window. In the arcane reasoning of the military, because we were part of an international force, the national emblem was affixed on the right shoulder of our BDUs (not on the left as was normally the case). Thus, the American flag was showing on the sleeve that was nearer to the open window.

In the United States, there were - and still are - many mixed emotions about the mission in Bosnia. Some were shared by the troops who were sent there. But whatever our feelings, it became immediately clear that the people who appreciated us most were the very old and the very young. Our presence allowed the old people to live their lives in dignity and the young to play in the sunshine, and both groups were always grateful.

As our vehicle inched through the village, two elderly Muslim gentlemen were drinking tea at a small table set right next to the road. We were so close that as we inched by, one of them reached out and touched the flag on my arm and said something to me in very passable English.

I smiled at him and for the rest of the drive wondered at his words. When I returned to my quarters, I asked about the significance of the expression the old gentlemen had spoken. It turned out he had used an ancient phrase - words with meaning so deep they were reserved for use in his culture only to express the most profound appreciation.

What the old man said when he touched the American flag was, "We will love you for a thousand years."

We love our spouses, our country, and our families. Let us always love what our flag represents for us and others.

### **REMINDER CONCERNING ONGOING PACMOAA COMMUNITY SERVICE**

As it turns out, adequate support of young parents in E-5 and below families is an ongoing issue. The baby pantry was established to address shortfalls in these families. Picking up some diaper rash cream or donating a few dollars that we can pool to buy more expensive items, would be very helpful. When you donate any small item or a few dollars that does not squeeze your budget can make a huge difference to these young military families. Thank you all for your service, whether as a military member or spouse.

## NEWS FROM MOAA

This year MOAA celebrates 90 years of advocacy for members of the uniformed services and their families. If you take a quick look at your MOAA email newsletter or your copy of *The Military Officer*, you will see that the game is afoot. Senator Doug Jones introduced MOAA backed legislation on February 28 (S. 622), **the Military Widows Tax Elimination Act**. Representative Joe Wilson introduced similar legislation (HR 553) **the Military Surviving spouses Equity Act** in January.

It is incumbent on us to support these efforts by mailing letters enclosed in the March issue of *The Military Officer* magazine or going to MOAA'S TAKE ACTION for online members. If we are indifferent, why should anyone else make an effort? [WALK THE WALK](#) click here to take action.

Current federal law requires survivors of deceased military members to forfeit part or all of their **purchased** Survivor Benefit Plan (SBP) annuity when they are awarded the VA's Dependency and Indemnity Compensation (DIC). For approximately 67,000 military survivors, the widows tax makes SBP the only insurance that you pay into but are legally prohibited from collecting.

"The SBP-DIC offset remains grossly unfair to the members of the military community who deserve our support the most," said Lt. Gen. Dana T. Atkins, USAF (Ret), President and CEO of MOAA. "We thank Sen. Jones for his leadership on this issue, and we encourage their fellow legislators to join the fight.

"The need to solve this inequity is uniformly agreed-upon throughout Congress, but they haven't found the political will to resolve it," Atkins said. "The 116th Congress has an opportunity to be known for getting this done." Help them develop the will with your input!
