## FROM THE PRESIDENT NOVEMBER 2019

The October dinner meeting again had 25 attendees, within the range of the 24 - 30 participants that we have averaged since January 2019. It was great to welcome 2 new members at their first meeting since joining PACMOAA - LCDR Paul Lucas, USN (Ret) and CAPT Jeff Westling, USCG (Ret). I sat at the Pharmacists table with Roger Hirsh, his guest CAPT Dennis Alder, USCG (Ret) and my husband Bruce's place card as he was not able to attend. Dennis was a PACMOAA member 10 or 15 years ago and it was really good to have him return. Some of you may remember CAPT Alder from the Pharmacy at the USCG base in Portsmouth.

CAPT Hirsh was the Pharmacy Department Head at NMCP for 5 years before retiring from active duty and was deployed to Operation Iraqi Freedom as Deputy Commander, U.S. Military Hospital Kuwait from 2004-2005. After retiring, Roger worked as a civilian in Pharmacy Informatics, i.e. computer systems manager at NMCP.

It was a pleasure to meet and listen to Delegate Steve Herretick. He represents the 79th District in the Virginia House of Delegates which covers major portions of Norfolk, Portsmouth and Chesapeake. Steve noted that he graduated locally from the College of William and Mary and that he chairs a committee of the National Board of Medical Examiners. On legislative issues, Steve is particularly interested in relief from the tunnel tolls and introduced several major bills seeking relief from them. When asked why some areas like Suffolk can have a monopoly on cable services provided, it was interesting to learn that currently, for a cable company to come into a new community, it has to submit paperwork to all cities/counties in Virginia to do so.

One of the measures Steve introduced in the legislature was to streamline this process so only one application needed to be submitted, thus decreasing the stranglehold some cable companies currently have.

Steve is a history buff and had a very interesting discussion about the Virginia General Assembly being the oldest continuously serving legislative body in the U.S. currently celebrating its 400th anniversary! Most people seem to think America was founded in 1775 but Steve noted that despite that thought in some circles, the pilgrims founded America. It was really founded in 1619, when 4 historic events happened

1. 1st elected democratic legislature in America (it was modeled initially like the British Parliament). It was not founded to escape religious persecution like Massachusetts but by people trying to get rich!
2. In a negative way, the first importation of slaves. Occurred 3 weeks after legislature formed.
3. Importation of women - all women in America before this were wives and some maids. This emphasized to the Indians that the foreigners were here to stay and helped lay the ground work for the Massacres to follow 3 years later.

Many other interesting historical facts were discussed including the huge impact of Virginians on the new county - George Washington, Thomas Jefferson, James Madison, George Wythe, James Monroe. It was also noted that Virginia covered most of North America until it was carved up over the years.

Discussion also followed on the current General Assembly and that everyone was up for election/re-election this November! Steve noted that they have gotten lots of new support for the ports over the past 10 years as well as trying to support improved cellular function. This year the economy is doing well with the biennial budget. There are about 3200 pieces of legislation presented each year. Every bill has to be cleared by the house and senate 1/2 way through the session and then crossed over. Members have about 3 seconds to vote on each bill, then they cross over and go through the same process again. Steve also stressed the importance of grass roots efforts like those Karl Wilson, PACMOAA Legislative Rep. and Hal Hostetler, Assistance Legislative Rep. make along with all PACMOAA members. Steve said that state legislators try to be more approachable than federal legislators and to call or email them if you have problems or issues as well as visiting them. He takes his local responsibilities very seriously.

Money, gun safety and school safety are several of the issues to be addressed this coming year. Steve also mentioned that Speaker of the House, Delegate Kirk Cox has taken gun control off the table and wants to focus on mental health issues instead. Virginia has more military per capita than any other state. Residents with 100% disability are tax exempt from state taxes now. Ongoing discussions with colleagues per sea level rise and the need to protect military facilities.

There was a fairly lengthy question and answer session. Jack Lyons asked about the way the legislature chose to handle the difference in the fed tax changes this year and the refund to citizens. The question per military retirees being tax exempt as they are in some other states or even having a portion of their retirement being tax exempt came up. Because there is such a large population of retirees in Virginia, Steve said this comes up in discussion frequently but felt like a change wouldn't happen anytime soon as there has to be money to cover difference in state income. Virginia is very conservative in preparing its budget and that is part of why we have such a good financial rating which in turn helps decrease interest costs. Marijuana The decriminalization of simple possession of marijuana was discussed. As you can see from this overview of his presentation, Steve Herretick was a very interesting and informative speaker! PACMOAA really appreciated him taking the time to visit and update us on Virginia history, especially for those who did not have Virginia history in elementary school, as well as current issues for the upcoming legislative session.



## 'Skinny' NDAA Leaves Out Critical Protections for Troops, Veterans, and Widows

Amid growing concerns lawmakers will be unable to come to an agreement on the annual defense authorization bill, Sen. Jim Inhofe (R-Okla.) introduced a “skinny NDAA” Oct. 29 to ensure essential defense programs continue uninterrupted.

While the new, \$738 billion bill authorizes next year’s 3.1% military pay raise, extends bonus and incentive pays, provides for quality-of-life programs for military families, and includes funding for military construction and acquisition programs, it leaves out several MOAA-supported issues that are addressed in either the House or Senate NDAA versions, or in both. This includes language that would:

- Prevent the [elimination of 18,000 medical billets](#).
- End the “[widows tax](#).”
- Require comprehensive [military housing reform](#).
- Stop changes and consolidations planned for the [commissary and exchange system](#).
- Fund necessary improvements to [military spouse employment and education resources](#).

The cuts cover over 1,900 pages of legislative text. Inhofe said he introduced a skinny NDAA “to preserve all options” to continue Congress’s 58-year streak of passing an annual defense bill.

*Holidays come around at their own pace,*

*whether we're ready for them or not. Personally, I've always enjoyed the season, which starts around Halloween and really doesn't end until the New Year.*

After the loss of my husband, that first set of holidays was a whirlwind. My blended family came around with little planning, as they made sure I wasn't alone or sad. They were grieving too, and it seemed natural to be together.

The years since that first set of holidays after my husband's death have not been as traditional. I'm ready to set a new tradition, but I find it difficult because the circumstances in my life have changed, as has my growing and changing family.

Last year, all the kids decided to coordinate spending every other year with their in-laws, and so it was the first year that I would have to find another way to spend Christmas without them. My sister invited me to spend Christmas Eve and day with her and her husband and her two grown kids. I accepted, but I had not expected it to be much fun.

It turned out to be one of the best times I'd had in years. We opened presents one by one, and it literally took six hours! It reminded me of the way my sister and I opened presents in our family when we were kids. Our dad always examined every gift and made a big deal out of the smallest things.

I left her house with a new perspective. I will try to keep an open mind about the holidays and remind myself the following:

- I am not alone.
- I'm thankful for even the smallest things
- I know there are people who care and want to help. I need to learn to accept help.
- I try not to worry or let fear take over. It's usually a waste of time.
- It becomes more evident that everyone who I have crossed paths with has been there for a reason.

As I move into the 2019 holiday season, I know there will be some struggles, but there also will be joys along the way.

PACMOAA has helped support PVH since November 2011 on a monthly basis with donations of needed supplies. Donations have fallen off significantly and are needed even more with all the onset of cold weather. Please consider donating whenever possible. Every little bit helps!

PVH, Inc., is a non-profit 501 (c) 3 corporation governed by a 13 member independent Board of Directors. Working with over 25 houses of faith in Portsmouth, Chesapeake & students from

Virginia Wesleyan College. PVH provides nightly shelter for homeless persons from mid-November through the beginning of May each year.

In addition to sheltering, PVH operates a 12 month Service Center where clients can shower, do laundry, receive their mail & telephone usage. Clients also meet with a case manager for support in becoming self-sufficient, Legal Aid, & receive referrals for mental health, substance abuse & employment counseling. PVH, Inc.'s early intervention with housing focused coaching & community partnerships has a proven track record helping to move individuals from homelessness to housing.

### 2019 Accomplishments

- **Served 229 distinct individuals** in winter shelter and service center services.
- Sheltered a total of **174 distinct individuals** for total of **175 night's** stay.
- Provided **11,197 units of service** (sheltering, showers, laundry, HRT bus passes, mail distribution, telephone usage, and housing documentation)
- Coordinated, staffed and managed inclement weather contingency sheltering (around-the-clock) for snow storms.
- Collaborated with homeless service providers to get **33 individuals** housed (2019).

#### **TRICARE AND FEDVIP OPEN SEASON 2020**

The 2020 TRICARE and FEDVIP open season will run from **Nov. 11 to Dec. 9, 2019.**

- Remember to Check with your preferred dentist to see what plans they are considered in network with and what they think your dental needs will be for the upcoming year. The new plan may differ from your current plan even with the same company.
- After looking at 9 out of the 13 High plans offered in my zip code for 2020, none had an annual maximum benefit per year if in network and it was usually \$2000- \$3000 per year if out of network. The only waiting period is for orthodontic care (usually braces).
- Some plans have a deductible but that is usually only if your dentist is out of network.
- Be sure to review the section in the plan brochure (available as pdf on the BENEFEDS website where plans are compared or can be mailed to you) on exclusions to coverage. For example, in the United Concordia Dental Plan brochure, in **Section 7 General Exclusions – Things We Do Not Cover:** one item listed is "Services and treatment performed prior to your effective coverage date including orthodontic treatment".

If currently enrolled in a FEDVIP dental &/or vision plan, you can keep the same plan but be aware that the plan may change for 2020. MOAA website:"Overall, FEDVIP dental rates will rise by an average of 5.6% for 2020; vision premiums will increase an average of 1.5%. The change in dental premiums range from a decrease of -5.9% to an increase of 9.5% depending upon your location. OPM states that the two primary factors drove increases this year; the health care insurance providers fee, which had been suspended in 2019 but reinstated in 2020, and an increase in utilization of services in a number of dental plans."
