TIMOTHY T. THOMPSON SR.

CAPTAIN, MEDICAL SERVICES CORPS UNITED STATES NAVY

A native of East Saint Louis, IL, CAPT Thompson enlisted in the Navy in 1987 and began his career attending basic training at Recruit Training Command and Hospital Corpsman "A" School at Naval Hospital Corps School, Great Lakes. CAPT Thompson then reported to Naval School of Health Sciences, San Diego where he attended Pharmacy Technician "C" School. Upon completion of training he reported to Naval Hospital Great Lakes for his first permanent duty assignment.

After four years of active service, he joined the Naval Reserves where he actively served for two years. In June 1998 he returned to active duty,

accepting the Navy's Health Services Collegiate Program Scholarship.

In 2000 he received his Doctor of Pharmacy Degree from Campbell University and was commissioned as a Lieutenant in the Medical Service Corps. His first assignment was Naval Medical Center Portsmouth, where he served as the Division Officer for Outpatient Pharmacy and later as the Pharmacy Department Head Naval Branch Medical Clinic Sewell's Point. In 2003 he reported to Naval Hospital Great Lakes as the interim Department Head and Outpatient Division Officer.

In 2006, he assumed responsibility as Pharmacy Department Head at Naval Hospital Pensacola. While assigned to Pensacola, he was selected to serve as a member of the Department of Defense Pharmacy and Therapeutics Committee.

From February 2009 to January 2010 he was assigned as an Individual Augmentee to Combined Joint Task Force Phoenix, in Kabul, Afghanistan with a Navy Medical Embedded Training Team in support of Operation Enduring Freedom, serving as a mentor to Afghanistan National Army Pharmacists.

After a six-month tour in Afghanistan he reported to Naval Health Clinic Cherry Point where he served as Director for Clinical Support Services and Pharmacy Department Head for four and a half years.

In 2014, CAPT Thompson was selected to serve as the Deputy Director for Clinical Support and Pharmacy Department Head at Fort Belvoir Community Hospital, one of the first Military Treatment Facilities (MTF) under the Defense Health Agency's leadership.

CAPT Thompson served as the sole pharmacist and Department Head for Ancillary Services at Naval Branch Health Clinic Gulfport, home of the Seabees, from 2017 to 2020.

He currently serves as the Associate Director for Clinical Support Services at Navy Medicine Readiness Training Command, Portsmouth and the Tidewater Military Health System Clinical Support Services Market Lead, where he provides professional and clinical oversight to 3 MTFs and 13 branch/troop health clinics.

CAPT Thompson's personal decorations include: Defense Meritorious Service Medal, Meritorious Service Medal (2), Navy and Marine Corps Commendation Medal (4), and various other personal and unit awards.

I was very sorry to hear that one of our longtime PACTROA/PACMOAA members died. CAPT Barreca was a





member for 30 years and he and Shirley used to attend dinner meetings frequently.

During his Naval career, Dr. Barreca attended the School of Aviation Medicine; was the flight surgeon for HS-7 (helicopter antisubmarine warfare squadron in Norfolk, Va.) and the Hurricane Hunter Squadron based at Naval Station

Roosevelt Roads, Ceiba, Puerto Rico; served on the USS Randolph and the USS Valley Forge; and served on the US Hospital Ship Sanctuary during the Vietnam War in 1969-70. He served as the Assistant Chief of Surgery at the Pensacola Naval Hospital. In the course of his years of service, he received many medals. His final duty station was the Naval Hospital Portsmouth, where he served as Assistant Chief of Surgery and Chief of Vascular Surgery. After serving his country for 20 years, he retired from the United States Navy with the rank of Captain in November of 1977.

A vascular and general surgeon, Dr. Barreca's office was located in Portsmouth; he had admitting privileges to Maryview, Obici, and Portsmouth General hospitals. He served as President of the medical staff at Portsmouth General Hospital.

After retiring from private practice, Dr. Barreca engaged in the study of investments at Old Dominion University, worked with H&R Block, and worked part time at the VA conducting physicals on fellow veterans. Dr. Barreca and his wife enjoyed traveling extensively with family and friends. One of their favorite places to relax was their house in Southern Shores on North Carolina's Outer Banks and visiting Hilton Head Island, S.C.

In his younger years, Dr. Barreca played the trumpet and competed in pole vaulting. Later in life, he enjoyed sailing on the Betty Lynn II and watching granddaughters Courtney and Alexis play school and travel softball. Dr. Barreca and his wife enjoyed being part of the Historic Downtown Portsmouth Community, living on Court Street for 40 years.

He was engaged in the community as a member of the Rotary Club of Portsmouth for 40 years, serving as club president in 2009-10, and attaining recognition as a Paul Harris +8 Fellow. He served as Chairman of Saint Paul Catholic Church Parish Council and Portsmouth Catholic School Board. In May 2019 he celebrated 50 years as a Master Mason of Escambia Lodge No. 15 of the Free and Accepted Masons in Pensacola, Fla.

Dr. Barreca is predeceased by his son, Joseph Pemberton Barreca, and his sisters, Doris Mahler and Marie Heimel. He is survived by his wife of over 66 years, the former Shirley Jean Chivé; their daughters Elizabeth Barreca Cherry (Chip) and Linda Barreca Perkinson (Bill), a partner in the law firm of Lane & Perkinson, P.C.;



his younger brother, Louis Barreca (Patsy), who resides in New Orleans; grandchildren Donald Cherry III (Whitney), Courtney Perkinson Bates (Kevin), Julia Cherry, and Alexis Perkinson; and great-grandchildren Noah, Caroline and Owen Cherry, and Miles Bates.

Advocacy in Action: MOAA Members Bring Our Message to Capitol Hill

More than 170 MOAA chapter members and board members from across the nation brought MOAA's legislative message to Capitol Hill on April 26 for the organization's annual Advocacy in Action (AiA) event.

Members spent the day inside the offices of House and Senate members, informing legislators and their aides about MOAA's top legislative priorities, including restoring the Basic Allowance for Housing (BAH) to 100% and preserving access to the TRICARE pharmacy network. It was the first time the event was held in person since 2019.


Jillian Rogers, a member of the MOAA Currently Serving Spouse Advisory Council, and Col. Kim Biever, USA (Ret), a member of MOAA's Uniformed Services Nurse Advocates Virtual Chapter, enjoyed their first AiA experience. They visited with staff from Texas Reps. Joaquin Castro, Tony Gonzales, and Henry Cuellar,

and walked away impressed with the positive reception and

their knowledge of military affairs. "All of them were eager to share what they were doing for

military families, veterans and servicemembers," Rogers said. "It was not what I was expecting."

Both Biever and Rogers have seen the impacts of the BAH cuts firsthand. According to Biever, there is a waiting list of over a year to live on base at Joint Base San Antonio, forcing many families to live off base and weigh quality-of-life decisions – commutes, neighborhoods, and school districts, for example – against living expenses. Rogers said despite having two incomes with her husband, a lieutenant commander in the Navy, making ends meet in Northern Virginia is still tough.

"We are seeking the best schools, so that usually means giving up on housing," said Rogers, who has three young children. "They are taking all of our BAH and a good chunk of the income I bring in [just] to be in a subpar rental house."

MOAA Northwest Arkansas Chapter President Col. Robert Crawford, USA (Ret), had never experienced in an in-person AiA but had participated in the last three virtual events. Crawford met with Rep. Steve Womack (R-Ark.) early Wednesday morning; Womack is working on a bill that would make the Basic Needs Allowance non-taxable for servicemembers, like BAH.

During his meeting with Womack, Crawford expressed the tangible benefits of restoring the BAH to 100%. While BAH rates vary by paygrade, location, and other factors, one MOAA calculation using DoD and other government figures found an E-5 in a military housing area representing the national average would receive \$111 more per month if BAH moved from its current 95% of housing costs back to 100%. This would partially lessen a \$433 gap between that servicemember's projected expenses and compensation.

"It's not going to make up for the shortfall, but it's going to make a dent," Crawford told Womack.

Virginia MOAA Vice President of Legislative Affairs Col. Monti Zimmerman, USA (Ret), and MOAA board member Col. Rojan J. Robotham, USAF, met with Rebecca Eichmann, a staffer from Rep. Abigail Spanberger's office, who said the Virginia Democrat would support restoring the TRICARE pharmacy network. Late last year, the network dropped thousands of independent pharmacies; the year before, it dropped Walmart from its rolls.

Eichmann cited her hometown near Orange, Va., where some servicemembers who had been able to use the local Walmart for their prescriptions needing to drive 40 minutes to Charlottesville to find a network pharmacy.

Illinois MOAA Council President Col. Robert Tyler, USMC (Ret), met with a legislative aide of suburban Chicago area Rep. Brad Schneider (D-Ill.) and spoke about the importance of earned benefits as a way to recruit more individuals to the military. Despite 83% of recruits coming from military families, fewer and fewer veterans are recommending serving their country.

"My son's father-in-law, who was a Navy captain, is telling his grandkids not to go to the military," Tyler said.

Overall, this year's AiA was a successful one, said MOAA Senior Director of Government Relations Cmdr. René Campos, USN (Ret).

"AiA is a great experience for local chapter members to reinforce MOAA's obligation to care for all who serve and have served," Campos said.

PACMOAA Involvement with Advocacy in Action 2023

MAJ Ferki coordinated visits with 4 Congressmen on the Hill for team led by CDR Linc Smith, USNR (Ret) with RDML Hewitt, USN (Ret).

PACMOAA team with MAJ Ferki, CAPT LaLonde and CDR Linc Smith will meet with Congressman Bobby Scott on 11 May via Zoom to review Advocacy in Actions issues for 2023.

MOAA, Other Advocacy Groups Send a Message to SECDEF: Protect TRICARE

The FY 2024 DoD budget request includes a mix of good news and potential concerns for TRICARE beneficiaries. As a leading voice on Capitol Hill regarding military health system (MHS) issues, MOAA championed a recent letter from The Military Coalition (TMC) urging DoD leadership to ensure the TRICARE benefit continues to provide the low out-of-pocket costs, comprehensive coverage, and access to quality care servicemembers and retirees have earned.

"Cutting benefits after they have been earned betrays the social contract that underpins the all-volunteer force" says the letter, sent to Secretary of Defense Lloyd Austin. "It is surely a factor in today's recruiting challenges as military families – key influencers – become less inclined to recommend military service to young people, including their own children."

MOAA was glad to see the FY 2024 budget request includes no proposals for TRICARE fee increases and suspends planned military medical end strength divestitures – an advocacy priority for MOAA since medical end strength reductions were proposed in 2019. With the help of our members, MOAA has achieved four successive halts to medical billet cuts, including a provision in the FY 2023 National Defense Authorization Act (NDAA) suspending medical billet reductions for five years and directing extensive DoD analysis and reporting.

According to the <u>budget request overview</u>, "The Department will use this directed pause to conduct an assessment of current military medical end strength to match operational requirements and enable the MHS to increase the medical readiness of the force, as well as the readiness of our medical force." DoD also will present a plan to Congress to address civilian backfill and persistent civilian vacancies or risks associated with medical billet reductions, according to the overview.

Purchased care administered by the TRICARE contractors is another important component of the MHS. Private sector care accounts for more than 65% of total care provided to beneficiaries, and the FY 2024 budget request includes a 7% increase in TRICARE funding.

Past TRICARE budget increases have prompted efforts to trim the benefit and/or shift costs to beneficiaries, as acknowledged by <u>further DoD budget documentation</u>: "Over the period from FY 2012 to FY 2018, both private health insurance premiums and <u>National Health Expenditures</u> per capita rose 25% (or 3.7% annually). The Private Sector Care budget should have continued to rise but the Department, with concurrence from Congress, instituted a series of initiatives that bent the cost curve. A combination of benefit changes, payment savings

initiatives, contract changes, and population reductions offset underlying increases in health care costs."



While the FY 2024 budget does not include TRICARE fee increases or new military health care benefit cuts, pressures on the MHS budget continue to be a concern. Protecting TRICARE is a top priority for MOAA, and our efforts will continue as MOAA members take part in our Advocacy in Action campaign to restore the TRICARE pharmacy network.

Boyd Nix addressed the VCOC officer slate for next year. He reports that he has contacted every chapter to solicit nominations for Council President. He has several "maybe" replies but nothing firm. He did say that he has a possible nominee for Secretary, and he will pass on details relating to that possibility to John Down.

Dan Merry of MOAA National was our guest speaker. He mentioned AiA dates of 4/26/2023 and talked about two other topics:

1. From the presentation, MOAA has two primary legislative objectives (goals) for this year. The first is to <u>restore Basic Allowance for Housing (BAH) status</u>. Discussion: From 2005 until 2014 we had 100% BAH. The Department of Defense (DoD) wanted

to reduce BAH from 100% to 95% in 1% annual decrements, beginning in 2015 until reached in 2019. Expectation was \$5B in savings. This particularly hurts our enlisted members and their families. While MOAA represents officers, it supports all ranks and desires that the reduction of BAH be redressed. Dan noted that to restore BAH will probably exceed \$5B.

2. The second major objective is to <u>halt the erosion of Tricare benefits</u>. Specifically, DoD cut 25% of the available pharmacy networks which especially hurts those smaller pharmacies in less populated areas. Independent analysis says that the cuts impacted rural areas, long term care, and specialty pharmacies. DoD did not look at impacts when they made the cuts. The MOAA goal here is to get DoD to look at the impacts.

Beginning January 9, 2023, you will be **REQUIRED** to activate your **NEW** prescriptions BEFORE heading to the NMCP Pharmacy, of your choice, with the help of Q-Anywhere!

Q-Anywhere

- •Text "get in line" to 1-833-217-2199 or scan the QR code, hit send and follow the prompts.
- •Get a text when your medications are ready for pickup.
- Text "I am here" upon arrival at the pharmacy you selected and listen for your "Q" number.



Important things to remembe

- Please note, Q-Anywhere function is available only during the selected pharmacy's operating hours. If the selected pharmacy is closed, you will receive a text indicating such.
- If you do not know the DoD ID of the dependent you are trying to activate a prescription for, simply enter the sponsor's DoD ID and text "DONE", when prompted. Once you receive a text stating "you are now in line" simply respond with the name of the dependent you are activating the prescription for as well as their date-of-birth.
