# **Surviving Spouse Corner: Facing Your Holiday Blues**

The holiday season is a time of joy. It's a time of get-togethers with family and friends. But it also can be the perfect storm of events and emotions. For those suffering the loss of a spouse, it might be overwhelming and a time of dread.

Some have a fear of going to a party alone, of becoming emotional, or being alone and lonely on days that used to hold so many happy memories. Others worry the weight of carrying their grief is visible and contagious. A few are trying to decide how much jolliness is appropriate, what lessons about grief and coping they are teaching their children and grandchildren, and whether the absence of decor and tradition signal the sadness and depression that surrounds us.

All these considerations can weigh one down, and the numbness sets in. Fortunately, there are some coping skills that work.

**Find your comfort zone.** Initially, you might feel you want to cocoon, and be antisocial. For most of us, crying is necessary. A lot of crying is best done privately. You also need time to focus on *your* health and happiness. Maybe you sit out the holidays. Eventually though, you must ...

**Embrace change.** After a necessary (your time frame) grieving period, accept the reality that no holiday will be the same again, and adjust.

#### [SURVIVING SPOUSE CORNER: Thrift Savings Plan Considerations]

Instead of the big holiday dinner at your house, take the family out. If it's affordable, rent a cabin in the woods or a house at the beach. Assign dishes for each guest to bring. Announce that your only responsibility is the turkey, gravy, and dressing. Relax. Do things simply.

If you and your spouse hosted an annual holiday cocktail party, and you feel up to entertaining, do something different. Alcohol is a depressant, and tears are harder to hold back if you've been drinking. Have a cookie-sharing party or a neighborhood open house.

Decorate, but keep it simple. Guests will enjoy the party whether your tree is 5 feet or 15 feet tall. A wreath trimmed with a red ribbon on the front door might be all you have the energy for, and it's enough!

Ask the leadership of your church, temple, or mosque for suggestions for changes in rites or religious ceremonies. Possibly a family member can assume the role your spouse held in presiding over a customary event.

If you are truly alone, find your solace and your footing in helping others. This will be a difficult time, but good times will follow. Many of us have been in your shoes. As you now know, that is why we are called "surviving spouses."

# NDAA Update: MOAA Priorities in Play as House, Senate Begin Final Negotiations

If lawmakers follow their own schedule, the FY 2024 National Defense Authorization Act (NDAA) should become law within three weeks, offering a legislative vehicle for many of MOAA's priorities which have reached the late stages of the NDAA assembly process.

House Speaker Mike Johnson (R-La.) made passing the NDAA by the close of 2023 part of his to-do list <u>shortly after taking the speaker's gavel</u>. Senate Majority Leader Chuck Schumer (D-N.Y.) told fellow senators in a Nov. 26 letter that the chamber would finish its work on the bill before the end of its current work period, which ends Dec. 15 (the House is scheduled to wrap up the day before).

Barring any extensions or exceptions, this points to a three-week period, at most, for negotiations between members of a joint House-Senate conference committee which will work out the differences between the chambers' NDAA versions. MOAA President and CEO Lt. Gen. Brian T. Kelly, USAF (Ret), outlined MOAA's priorities for this must-pass bill in <u>an August letter to legislators</u>. Highlights include:

- **Protecting Your TRICARE Benefit:** MOAA supports a House provision (Section 765) which would require a detailed Government Accountability Office (GAO) report on access to the TRICARE pharmacy benefit a report necessitated by significant cuts to the retail pharmacy network.
- **Restoring the Military Housing Benefit:** MOAA supports House NDAA language increasing the Basic Housing Allowance (BAH) to 96% of local rental and utilities costs, up from the current 95%. This would be a meaningful step toward restoring the full 100% benefit, a position championed by MOAA in this year's Advocacy in Action campaign.

[TAKE ACTION: TRICARE Pharmacy Access | BAH Restoration]

- **Boosting Servicemember Compensation:** Along with a 5.2% pay raise to keep pace with the private sector, MOAA supports language in the House bill reforming the military pay table, which would result in higher pay for younger members and help combat ongoing recruiting challenges.
- **Preserving Earned Burial Benefits:** As Arlington National Cemetery (ANC) nears capacity, MOAA supports language in the House bill requiring a report on potential locations of the "next ANC," which would eliminate the need for new eligibility rules at the current location and protect this earned benefit for generations of retirees. - Strengthening DoD Hiring Power: MOAA supports a House NDAA provision eliminating the so-called "180-day rule," which would allow DoD to tap into a talented pool of military retirees immediately to meet its staffing requirements. (Learn More | Take Action).

#### **Understanding the Unseen Costs of a Continuing Resolution**

As we approach the third month of the new fiscal year, the government remains budget-less – operating under its second continuing resolution (CR) ... and continuing a long tradition of a broken funding process.

Since the start of the fiscal year moved to Oct. 1 with the 1977 budget cycle, Congress has passed at least one CR in every year but three. The last year without a CR was 1997. DoD's plans to operate without a budget have become "routine in nature," according to a 2021 Government Accountability Office (GAO) report, regularly postponing contracts or training in anticipation of budget gridlock.

Alongside routine preparation comes routine waste – money that could be going to address systemic issues within DoD, from <u>horrendous barracks conditions</u> to <u>ongoing recruiting challenges</u>, and could be used in support of preserving the service-earned benefits MOAA fights to protect.

#### [TAKE ACTION: Ask Your Lawmakers to Pass a Budget]

Multiple reports from various agencies point to a lack of study into the full costs of CRs. In 2019, then-Defense Secretary Mark Esper said the lack of a budget cost the department \$19 billion. And two years earlier, then-Navy Secretary Richard Spencer added a compelling visual to his financial outlook.

"We have put \$4 billion in a trash can, poured lighter fluid on it, and burned it," <u>Spencer said</u> in describing the money lost by his department due to CRs from 2011 to 2017.

#### **Lost Funds**

An Air Force contracting offer outlined this wasteful process writing <u>for The Government Affairs Institute at Georgetown University</u>:

- **Mismatched Money:** CRs offer limited budget flexibility, so if a program is ready to move from testing to production, for instance, it may be stalled instead, with no money allocated in the production budget and funds going to waste in the testing budget.
- The Price of Planning: Appropriators must spend time and money preparing for potential shutdowns, moving around what funds they can to anticipate CRs, and making other costly last-minute adjustments.

• **Hiring Headaches:** "As a previous Squadron Commander, with hiring authority for the civilian personnel assigned to the unit, I can attest that attracting and hiring talented employees was made more challenging by the limitations and fiscal uncertainty caused by the CR," Lt. Col. Timothy Cabana wrote. "The demand for talent is high and high performing workers did not wait around for the government to pass a budget before taking another position."

On top of this waste comes a new wrinkle for the current CR – an automatic 1% across-the-board budget cut if Congress hasn't passed a full budget by Jan. 1, with no exception for DoD or the VA, under <u>language in the 2023</u> debt ceiling deal.

#### **Ending the Cycle**

While members of MOAA's advocacy team have taken these issues to key lawmakers repeatedly, these representatives and their staffs need to hear from those who matter most – their constituents.

<u>Send a simple message</u> through our Legislative Action Center and make it clear to your senators and House members that the status quo of costly CRs isn't acceptable – not when so much needs done to maintain the strength of the all-volunteer force. Share the link with your network: You don't have to be a MOAA member to join the action center and participate in all of MOAA's ongoing advocacy efforts.

Constant pressure from constituents can snap this cycle and end an all-too-regular (and wasteful) rush to fund the government at year's end. Make your voice heard today.

#### Legislators Back MOAA-Supported Plan to Help End Hunger in the Ranks

A bipartisan group of 20 lawmakers asked leaders on the House and Senate Armed Services committees to include a provision in the annual defense authorization bill expanding the Basic Needs Allowance (BNA) to cover more of the 286,000 servicemembers and their families facing food insecurity.

<u>The Oct. 23 letter</u> came about a month after <u>a letter addressed to the same committee leadership</u> from MOAA and other advocates in support of the same provision – Section 621 of the House version of the FY 2024 National Defense Authorization Act (NDAA). The provision would exclude the Basic Allowance for Housing (BAH) from BNA calculations, meaning more servicemembers would qualify for the assistance established in the FY 2022 NDAA.

Less than 3,000 servicemembers receive BNA under its current setup, according to the letter. Making a "common-sense adjustment to the eligibility guidelines for the BNA will help ensure the majority of military families who struggle with food insecurity are able to access this critical support," the letter reads.

#### [TAKE ACTION: Ask Your House Member to Strengthen the Basic Needs Allowance]

The NDAA provision mirrors <u>H.R. 1764</u>, the bipartisan Military Food Security Act of 2023. The MOAA-supported legislation would change the existing BNA regulation, which allows service secretaries to remove BAH from income considerations in some circumstances, and require such removal for all who seek assistance. The bill does not have a Senate companion, but the Oct. 23 letter includes the signatures of 11 senators, such as Tammy Duckworth (D-III.) and Lisa Murkowski (R-Alaska).

The NDAA provision is just one MOAA-supported section designed to improve quality of life for servicemembers and their families. Others address issues such as:

• **BAH Restoration:** House Section 4401 would increase the BAH rate to 96% of local rental and utilities costs, up from the current 95% and on the way to the MOAA-supported restoration of 100%.

- **Family Separation:** House Section 628 would increase the Family Separation Allowance to \$400 per month.
- Child Care: House Section 643 would assist DoD in staffing its child care centers by providing discounted child care for these workers.

Supporting military families, especially younger families who may be more vulnerable to economic insecurity, remains a key priority for MOAA ... and should be a key priority for lawmakers as the NDAA enters the stretch run. Your messages to your representatives make a difference – if you haven't already, be sure to register for MOAA's Legislative Action Center so you can engage with your legislators on these issues and others.

"Our servicemembers are our military's greatest resource," the letter states. "When they experience hunger, we put our national security at risk. We must give members of our military every possible tool to focus on the mission and be ready to defend our Nation when called to action."

#### MOAA Council Leader Recognized for Tackling Military Issues at the State Level

Col. Monti Zimmerman, USA (Ret), pictured at right, is described as "fearless" by those who work with him on legislative issues that advance military initiatives in Virginia, including spearheading MOAA efforts to reduce the state income tax burden paid by Virginia military retirees.

For his doggedness and results, Zimmerman has been named the 2023 recipient of the <u>Colonel Steve Strobridge Legislative</u> <u>Award</u> at the council level.

Among his volunteer roles are serving as the <u>Virginia Council</u> of <u>Chapters</u> third vice president and legislative affairs chair,



Zimmerman retired from the military in 2016 after a 30-year career that took him from the Air Force to the Army National Guard and the Army Reserve. He deployed to Bosnia and Afghanistan, where he rode horses with special operations forces and worked with the two warlords who are portrayed in the movie *12 Strong*.

A Life Member of MOAA, he attended a MOAA retiree appreciation event and was asked to participate in the <u>Northern Virginia Chapter</u> of the Virginia Council of Chapters. He decided to focus on state legislation.

"Most people don't understand how their state legislatures work and then don't understand how to actually properly advocate to make an impact or a difference," he said. "I determined that I can make a greater impact working on the state of Virginia than I could working on federal legislation."

His leadership in an effort to reduce state income taxes paid by Virginia military retirees resulted in the passing of a tax deduction for the first \$10,000 of their retired pay for 2022 with an increase to \$20,000 for 2023 and an additional \$10,000 for each of the next two years. The tax break starts at age 55, but Zimmerman is actively engaging legislators to remove the starting age and to include retired members of the U.S. Public Health Service and NOAA.

#### [RELATED: MOAA's Military State Report Card and Tax Guide]

An issue Zimmerman has become passionate about is providing surviving spouses of those who died on active duty, not killed by enemy, with the same accrued benefits as those killed by enemy.

"In Department of Defense actuaries, those two groups are treated identical, but as far as state benefits accrual, some states treat them as polar opposites, so killed by enemy get all these benefits; died on active duty get nothing."

He's been shepherding an initiative that would provide property tax relief for surviving spouses of those who died on active duty and expects a constitutional amendment eliminating the disparity will be included on the November 2024 Virginia general ballot.

National Guard Maj. Kevin Hoffman, JLC chairman, worked with Zimmerman to rectify pay scale inequities for Virginia Guard members and to make needed changes to a tuition assistance program.

He describes Zimmerman as fearless.



"He will go up to any legislator at any time, at any place and talk to him or her about whatever MOAA or JLC or Guard Association issue is in his mind at the time. He will be talking and he'll be engaging and he'll gain support. It's remarkable."

## PLEASE CONSIDER BRINGING DONATIONS TO PORTSMOUTH VOLUNTEERS FOR THE HOMELESS (PVH) TO PACMOAA CHRISTMAS GALA

**Excerpts from PVH Executive Director's Update on 18 November 2023** 

It has been 1,469 nights of <u>continuous</u> and <u>uninterrupted</u> sheltering for us since the opening of our regular Winter Shelter\_season in November 2019. Our shelter services would have typically\_been 175 nights from mid-November to the beginning of May.

We have successfully sheltered through the devastating impacts of a highly contagious novel respiratory disease in a congregate environment, not experiencing our first Coronavirus outbreak until January 2022 –two years into the public health disaster.

As state and federal funding have shifted to managing an endemic public health event, the day-to-day reality of what's happening on the ground is still tenuous.

The end of emergency pandemic funding, including hotel vouchers and rent/mortgage/utility assistance is driving households into homelessness and seeking shelter.

Economic disruptions have had greater adverse impacts within homeless populations and our communities need more time to recover.

PVH's "Service Center-to-Shelter" model which extended shelter services from a 6-month operation to 12-months has been successful in keeping our homeless citizens safer, protected and focused on rebuilding their lives. Emergency shelter with coaching provides a safety net to continue work on re-housing plans and barriers.

Partnering with other providers, we have assisted with -

**Individual housing** 

Securing SNAP benefits

Securing DD214 documentation

Helping secure birth certificates, social security cards and government issued photo identification cards Helping many secure employment

Achieving these milestones would be significantly more difficult without being able to provide a safer night sleep as well.

We are extremely grateful to our supporters, friends, donors and volunteers for standing with us from the beginning...you are our Cheerleaders!

Grateful to the many churches, civic, social and fraternal organizations who respond to our needs throughout the year, helping us meet financial gaps.

Note: PVH has coordinated continuous uninterrupted night sheltering since the pandemic began.

On-going PVH Service Center and Shelter material donation needs are listed below from 27 November Update.

- Disposable gloves (non-latex), Toilet paper
- 3-ply masks
- Kitchen trash bags, large garbage bags
- Room deodorizer (solid)
- Bathroom cleaner

They can still use laundry detergent, personal care products, etc.

**Note**: PVH is a non-profit 501 (c) 3 corporation governed by a twenty-one (21) member independent Board of Directors. Before COVID, PVH provided nightly shelter for homeless persons in partnership with local faith communities, social and civic organizations, from mid-November to April. They provided a twelve (12) month

Outreach Service Center where clients could shower, do laundry, receive their mail and use the telephone. The Outreach Service Center continues to serve with extended hours from pre-pandemic.

PACMOAA had donated items to this most worthwhile organization since their Executive Director, Delores Washington (pictured at right) spoke at our meeting in October 2011. PACMOAA donations have fallen off over the past 3 years, but the need is ongoing! Every little bit helps!
