

## **GUEST SPEAKERS**



**Disabled American Veterans (DAV) - Cynthia M. Madison.** Ms. Madison, a service-connected disabled veteran, retired as a Sergeant First Class in 1996 from the U.S. Army after 20 years of service. Cynthia was the Personnel Sergeant now known as Human Resource. She had assignments to Fort Gordon, GA, Stuttgart Germany, Fort Ritchie, MD, SHAPE Belgium, Fort Benjamin Harrison, IN, and Camp Hovey, Korea where she was assigned to the 2<sup>nd</sup> Inf Division. Her final assignment was Syracuse, NY where she was assigned to a recruiting Battalion. Ms. Madison was awarded the Meritorious Service Medal with 2<sup>nd</sup> Oak Leaf Cluster, the Joint Service Commendation Medal, the Army Commendation Medal with 2<sup>nd</sup> Oak Leaf Cluster, the Army Achievement Medal, Army

Medal with 2<sup>nd</sup> Oak Leaf Cluster, the Army Achievement Medal, Army Good Conduct Medal (6<sup>th</sup> Award) the National Defense Service Medal, the Non Commissioned Officer Professional Development Ribbon with numeral 3, the Army Service Ribbon, the Overseas Service Ribbon (3<sup>rd</sup> Award) and the Marksman Service Badge.

Cynthia joined the Disabled American Veterans in 2002 and became active in her local chapter in Portsmouth, Virginia and the Department of Virginia. Currently she was the adjutant for Portsmouth Chapter 27. In 2011 Ms. Madison was elected as the Department Commander. She is the assistant adjutant for the Department of Virginia. Between 2011 and 2015 Ms. Madison was instrumental in chairing five DAV Walk for Veterans for the Department of Virginia which she helped raise over \$80,000. 2016 and 2017 Ms Madison chaired the National Series Newport News DAV 5K run, walk roll and motorcycle ride that honors our nation's heroes. The DAV 5K National Series Newport News held in honor of Veterans Day November 5, 2017, raised over \$121, 260.41. She continues to honor our Veterans every year for Veterans Day in which our Thrift Stores does a Point of Sales Campaign. All money raised during this campaign goes back out into the community to assist our veterans during the time of need.

Within the National Organization, Cynthia Madison served on the Employment Committee, the Nominating Committee and the Credential Committee. During the period 2013-2014 Cynthia was appointed as National Chief of Staff and 2015-2016 she served as Aide to the National Commander. Currently Cynthia is the 3rd National Jr Vice Commander for the DAV.

Cynthia attended Averett University and received a Bachelor of Business Administration in 1999 and Troy University in which she received a master's degree in human resource management in 2007. She has one daughter Nicole who resides in Maryland.



**Veterans of Foreign Wars (VFW) Gary Adams** joined the US Navy in 2008. He went to boot camp at the age of 38 and did very well at standing still and shutting up. For many it was hard. Gary was a corrections officer at the time and following orders came natural to him. He went to Master-At-Arms A School and learned to be a Navy Police Officer and was Top Gun in his class. Later that year he volunteered for a detainee ops mission in Iraq. There he made the rank of Third-Class Petty Officer (E4) in just over a year and a half. Adams was selected as Blue Jacket Sailor of the Year in Iraq in 2009. He earned an Army Achievement Medal, a Navy and Marine Achievement Medal, and an Iraq Campaign Medal, among others. He joined the Veterans of Foreign Wars as soon as he returned home.

After Iraq Gary Adams went to the Navy Reserves and served from 2009 to 2016. He was attached to both the Washington Navy Yard and Northwest Annex in Chesapeake, VA. While a reservist he earned his Emergency

Vehicle Operators Trainers Certification, as well as his Small Arms Marksmanship Instructor Certification and kept his unit members mission ready. While in the Reserves he attended college on the Reserve Education Assistance Program and earned two degrees. His first degree was in Business Management and Leadership, and his second degree was in accounting. Adams says he uses these skills everyday in the Veterans of Foreign Wars.

He became a life member of the VFW in 2013, but really became active when he took over as post quartermaster in the spring of 2015 because of an illness of the current officer who died shortly after. It turned out to be trial by fire he says. He had very little time with his mentor. In 2016 he took over as district Quartermaster for the same reason. Again, trial by fire. In the summer 2019 he took District Commander for one year but had to give it up the following year to become the State Surgeon in 2020. In June 2023 he became State Commander of the Department of Virginia.

He has been married to Tammy Adams for 33 years. They have two children, a daughter Katie 28 years old, and a son Jacob 25 years old. Tammy and Katie are both self-employed in health insurance. Jacob runs his own 120-acre Four-wheel drive off-road park in Troy, NC. They all live in Cana, VA near the town of Mt. Airy, NC famous for the hometown of Andy Griffith.



**AMERICAN LEGION** - Kirk Jefferies has been an American Legion member for 45 years, serving as 2<sup>nd</sup> District Commander in 2000-2001, Post 310 Commander for the last 12 years, a Commander member at State level in Baseball and JSSP. He helped to get Horton Veterans Memorial Cemetery off the ground and running. He is a member of the Lutheran Church in Portsmouth and served with the Coast Guard for 6 years (1 year in Vietnam).

## Surviving Spouse Corner: Know Your Benefits

Many states have made legislative decisions that show appreciation for the sacrifices of servicemembers and veterans and their survivors. Benefits differ in each state, though. To know what the benefits are in your state, you need to do homework. Your research could result in monetary savings and opportunities.

Below are some resources and places to start.

• Veterans Service Office: There might be printed materials that enumerate county and state benefits for surviving spouses.

• **MOAA Council and Chapter Legislative Chairs:** Ask about benefits they are aware of that apply to surviving spouses.

• **County Property Appraiser:** Ask about a homestead exemption, a widow (widower) exemption, or an over age 65 exemption on your property tax or school tax. If income caps apply, what are your state's limits and guidelines? In Florida, for example, there is a homestead, widow, and age exemption and property taxes on homesteaded homes. In addition, the property tax for homesteaded homes of disabled veterans is reduced by the same percentage of the disabilities affecting the veteran as certified by the VA. In Florida, that benefit passes to the un-remarried surviving spouse and is transportable to a downsized home.

• **State Legislator:** If you have income tax in your state, some or all of your military retirement pay, or Surviving Benefit Plan may be deducted from your reported income. Ask about any other benefits from the state.

• Mayor's Office: Call and ask about the benefits the city offers.

#### [RELATED: MOAA's Military State Report Card and Tax Guide]

Aside from taxes, some additional areas to explore are scholarship opportunities for surviving spouses and dependent children; state, county, or city policies giving employment and/or promotion preference to a surviving spouse; portability of a professional license or forgiveness of fees; and discounts on passes to parks and museums.

### **VETERANS AND PARKINSON'S**

As the Personal Affairs Chair, over the past few years, I have noticed that at least 5 of our members/spouses have had some variation of Parkinson's. The Parkinson's Foundation has a wealth of information and resources for veterans and their families.

"More than 110,000 veterans with Parkinson's disease (PD) receive care through the U.S. Department of Veterans Affairs (VA). The Parkinson's Foundation and the <u>U.S. Department of Veterans Affairs (VA)</u> have

partnered to improve the health, well-being, and quality of life for veterans living with Parkinson's.

Most people with Parkinson's develop symptoms at 50 years of age or older. One million people in the U.S. live with Parkinson's today. This number will rise as our population ages, as will the number of veterans diagnosed with the disease. While living with Parkinson's can be challenging, an early diagnosis and beginning <u>treatment</u> can help people live well with Parkinson's.

While the exact cause of Parkinson's is unknown, research suggests that its cause can be linked to <u>genetic</u> and <u>environmental factors</u>. In addition, for some veterans, developing Parkinson's disease can be associated with exposure to <u>Agent Orange or other herbicides</u> during military service. Veterans with PD who were exposed to certain herbicides during their service may be eligible for disability compensation and health care.

For everyone with Parkinson's, an accurate diagnosis is critical because treatments and resources are available to help people with Parkinson's live better lives. Many U.S. military veterans with Parkinson's have access to specialized medical care and financial assistance through the U.S. Department of Veterans Affairs (VA).

Veterans and their families can call 1-800-MyVA411 (1-800-698-2411), a single access point to all VA contact centers. The number is available 24 hours a day, 365 days a year to serve Veterans, their families, caregivers and survivors." from Veterans & Parkinson's | Parkinson's Foundation.

### Good, Bad, and Ugly: 3 Paths for the Ongoing Budget Crisis

Although Congress passed <u>yet another continuing resolution</u> (CR) late Feb. 29, the clock still is ticking on a potential government shutdown.

After the latest CR, Congress now needs to pass 12 funding bills – six by March 8 (including funding for the VA and military construction) and the rest by March 22 – to keep the government open. Aside from temporary CRs, Congress has three primary options:

[TAKE ACTION: <u>Ask Your Lawmakers to Avoid a Government Shutdown and Finish the</u> <u>Appropriations Process</u>]

### **1. Full Funding**

The preferred option - passing all the spending bills, either individually or as part of an omnibus package - would fund the government through the end of the year. All the attention is on the House of Representatives, including Speaker Mike Johnson (R-La.) and the razor-thin Republican majority.

Passing these bills likely will require some Democratic support, which complicates the situation. Johnson made it "<u>unequivocally</u>" clear that he wants to avoid a shutdown, and the bipartisan path risks <u>angering members</u> of

his own conference. An agreement has been reached on some of the bills including military construction and VA appropriations, according to <u>a Feb. 28 joint statement by House and Senate leaders</u>; DoD funding negotiations continue.

### 2. Yearlong CR

The second option is to pass a full-year continuing resolution, which would push DoD into uncharted territory. As Secretary of Defense Lloyd Austin highlighted <u>in his Nov. 29 letter</u> to the lead Senate appropriator, Sen. Patty Murray (D-Wash.), DoD has never operated under a full-year CR.

This arrangement "would misalign billions of dollars, subject Service members and their families to unnecessary stress, damage our readiness, and impede our ability to react to emergent events," Austin wrote in the letter.

In addition to losing ground against the pacing challenges of China, this path would force DoD to deal with a multibillion cut to military personnel accounts.

### 3. Federal Shutdown

The last, worst option brings not just uncertainty for DoD budget-planners, but potential financial disaster for those in uniform: Unlike past shutdowns and shutdown threats, Congress has not passed any legislation protecting servicemember pay should the government run out of money.

Without that agreement, all uniformed servicemembers would be subject to the challenges members of the Coast Guard, as well as those in the commissioned corps of the U.S. Public Health Service and NOAA, <u>faced in</u> <u>2019</u>, when pay protections were limited to DoD branches.

While Congress should have serious policy debates about spending levels, shutting down the government does not advance such discussions. A shutdown is ultimately wasteful and prevents DoD from moving funds to important things like construction projects that support quality of life infrastructure for our servicemembers and their families.

<u>Write your lawmakers today to make your voice heard</u> – Congress needs to pass the funding bills our community relies upon.

# TRICARE For Life, Star Act, Housing Help Will Anchor MOAA's Spring

The three issue areas comprising this year's Advocacy in Action (AiA) campaign show the range of MOAA's legislative priorities – not just for officers, not just for retirees, and not wavering on our commitment to long-term advocacy goals.

### **Concurrent Receipt**

**What's at Stake:** The Major Richard Star Act (H.R. 1282/S. 344) would end an unjust offset for combatinjured veterans who lose a dollar of service-earned retirement pay for every dollar of VA disability compensation. The bill has a supermajority of bipartisan support – more than 325 House co-sponsors and more than 70 in the Senate – thanks in part to past grassroots efforts from MOAA and partners in <u>The Military</u> <u>Coalition</u>.

**MOAA's Mission:** We need to keep up this momentum and secure the bill's inclusion in the FY 2025 National Defense Authorization Act (NDAA). It's time for lawmakers to push this long-delayed step toward concurrent receipt for all past the finish line.

### **Full Housing Allowance**

**What's at Stake:** The BAH Restoration Act (H.R. 2537/S. 1823) reverses DoD policy capping the Basic Allowance for Housing (BAH) at 95% of local rental and utilities costs – a policy that's placing a financial burden on servicemembers and families in the middle of a nationwide rental shortage *and* ongoing recruiting challenges. Restoring this benefit – it was cut by Congress incrementally beginning in 2015 – would make a difference in the quality of life for all who serve, but especially among junior enlisted members and their families, who rely on this allowance as a large percentage of their compensation.

**MOAA's Mission:** Language requiring an incremental increase reached the late stages of the FY 2024 NDAA process but ultimately was not included in the final bill. We must send a message to lawmakers that close isn't good enough – servicemembers deserve a full housing allowance, and more progress must be made this legislative session.

### TRICARE For Life

**What's at Stake:** Protecting TRICARE For Life (TFL) remains a key issue for all MOAA members – those already covered by TFL and Medicare, along with those who'll use the benefit when they turn 65. MOAA remains concerned about a <u>Congressional Budget Office (CBO) report</u> suggesting two measures which would severely weaken the benefit – enrollment fees topping \$1,100 per family, and cost-sharing requirements including an \$850 deductible and up to \$4,675 in potential yearly medical bills.

**MOAA's Mission:** Legislators seeking solutions to budget gaps must hear a clear message: Maintaining TFL is not just a national obligation to those who spent decades in uniform, it's also critical to ensuring key influencers in the recruiting process aren't discouraged from recommending uniformed service to future generations. While TFL fees or cost shares aren't part of any current legislation, we must counter CBO's misguided options with our grassroots advocacy efforts. The next CBO release is slated for December of this year, following the elections; MOAA will update our members as soon as we get the report.

### **Overview Of MUSNAVC Meeting And Legislation Early Push**

The MOAA Uniformed Services Nurse Advocate Virtual Chapter (MUSNAVC) represents Army, Navy, Air Force, and USPHS nurses that are active duty, reservists, or retired and focuses on **advocacy of Health Care Issues**! As of 21 February 2024, it had over 500 members in all 50 states representing 214 congressional districts! In 2018 when I first joined, the chapter had 62 members in 22 states that represented 48 congressional districts.

I became active in 2020 when MOAA's Advocacy in Action focus was to get Congress to re-evaluate the military health system reform. The Take Action request -Ask your members of Congress to join the fight to halt billet reductions and end military treatment facility downsizing amid COVID-19 uncertainty.

The speaker at the most recent monthly meeting in February was Dr. Mona Treyball ,a retired Air Force nurse and Professor of Clinical Teaching Specialty Director of Veteran and Military Health Care Program at the University of Colorado College of Nursing. Dr Treyball feels strongly that we need to look at the military/veteran health as a specific population. That being said, she stressed the differences in the veterans from different wars in terms of the environment they were in and common medical conditions they experienced. Veterans from all wars experienced PTSD.

The classes are all online except for clinical experiences and the program just graduated the first DNP (Doctor of Nursing Practice) students in December 2023. There is also a graduate certificate open to all people not just RNs. Several MUSNAVC members asked about taking an individual course and that is possible.

Following the presentation, the **MUSNAVC Legislation Early Push** section was reviewed on the website at Legis Early Push | musnavc. Health care issues not currently covered by MOAA Legislative Active Campaigns but supported by the MOAA Healthcare Committee and the Military Coalition are addressed here. "The selected legislation is currently before Congress; have bipartisan support; are healthcare related; and considered attainable of passage" per MUSNAVC website. The link for each bill shows background information, the actual bill text, and lists house & senate sponsors as well as gives suggested messages for both.

## March equinox 2024: All you need to know about it

What is it? The March equinox marks the sun's crossing above the Earth's equator, moving from south to north.

When is the next one? It'll happen at 3:06 UTC on March 20, 2024

Note: The March equinox – aka the *vernal equinox* – marks the beginning of spring in the Northern Hemisphere

and autumn in the Southern Hemisphere. No matter where you are on Earth, the equinox brings us a number of seasonal effects, noticeable to nature lovers around the globe.

#### Equal day and night on the equinox?

At the equinox, Earth's two hemispheres are receiving the sun's rays equally. Night and day are often said to be equal in length. In fact, the word equinox comes from the Latin aequus (equal) and nox (night). For our ancestors, whose timekeeping was less precise than ours, day and night likely did seem equal. But today we know it's not exactly so.

#### **Fastest sunsets at the equinoxes**

The fastest sunsets and sunrises of the year happen at the equinoxes. We're talking here about the length of time it takes for the whole sun to sink below the horizon.

#### Sun rises due east and sets due west?


Here's another equinox phenomenon. You might hear that the sun rises due east and sets due west at the equinox. Is that true? Yes it is. In fact, it's the case no matter where you live on Earth, with the exception of the North and South Pole. At the equinoxes, the sun appears overhead at noon as seen from Earth's equator, as the illustration below shows.


This illustration shows the sun's location on the celestial equator, every hour, on the day of the equinox.

No matter where you are on Earth – except at the Earth's North and South Poles - you have a due east and due west point on your horizon. That point marks the intersection of your horizon with the celestial equator: the imaginary line above the true equator of the Earth.

The sun is on the celestial equator, and the celestial equator intersects all of our horizons at points due east and due west. Voila! The sun rises due east and sets due west.
