The TRICARE Benefits Briefing at the March meeting was very informative. Both Juanita Small, TRICARE Contact Representative, and Linda Watson, Manage Care Support Liaison with Humana Military at NMCP, attended. Linda spoke with members before and after the briefing about their individual concerns.

Juanita brought great packets that included a copy of her power point presentation as well as many fact sheets and brochures. I can obtain more packets for anyone interested that missed the presentation or email you a copy of the power point presentation. Just let me know. Juanita has a great presentation style and provided many helpful tidbits of information. TRICARE Standard is now TRICARE Select Option and has a fixed percentage for network providers. She reviewed TRICARE Select Options; Medicare eligibility; TRICARE for Life (TFL) eligibility as well as Medicare part A, B, C and D. A change in TFL is that participants have a lower priority for access-to-care at military treatment facilities (MTF). Of interest to many of us was that TFL/Medicare part A covers hospitalization and skilled nursing/rehab. Very detailed information per TFL and both parts of Medicare part A including costs and Medicare part B were reviewed and are in the power point handout. Dental coverage and the phasing out of the TRICARE retiree dental program at the end of 2018 and the beginning of the Federal Employee Dental and Vision Insurance Program (FEDVIP) was discussed. Scott Dickinson noted that he and his wife Heather are

in that program and have been very pleased with it. Juanita mentioned that there are about 10 different eligible providers under FEDVIP and recommended reviewing them all carefully. Even if you had the TRICARE retiree Delta Dental program, you would be signing up for a new program and many programs have different time frames for when they cover most of your dental needs.

Pharmacy changes was another big topic of interest. Please see the article included in this newsletter discussing the rationale behind the increased charges. A table describing the increases in home delivery and retail pharmacies (both network and out of network) was included. It was also noted that there is no charge at MTFs but that they have a limited formulary.

There were many questions during the presentation and after the business meeting. Juanita mentioned that there are monthly TFL briefings. They are held the 2nd Tuesday each month from 0900 - 1100 in the Internal Medicine Conference Room, BLDG 2 (main hospital), 2nd floor. No registration is required. For any questions call Juanita (757) 953-0434. Juanita and Linda both graciously stayed for a while after the meeting to answer questions. We did not have a large attendance and sadly anyone not there missed one of the most helpful presentations we have had in some time. The program was very well received by those attending.

## LEGISLATIVE REPRESENTATIVE REPORT

Prior to the last VCOC meeting, I met with local legislative representatives Lincoln Smith of the Hampton Roads Chapter and Jim Pauls from the Virginia Peninsula Chapter. James Smith and James McLaren of HRCMOAA were also in attendance.

The meeting was held at the Virginia Beach Resort and Conference Center on 13 January 2018 at 10 am. This was a follow-up meeting to discuss the Veterans Entrepreneurship Capital Resource Program. (VECRP). Jim Pauls wanted to ensure the three Tidewater area chapters of MOAA would be in support of the VECRP during the scheduled January 21st VCOC meeting to be held in Richmond. The decision was made to have the three Tidewater area chapter's legislative representatives meet quarterly to promote our common interests within the VCOC.

PACMOAA attendees at the January 21st meeting were myself, Jim Stephens, Dolly Cherrington, and Hans Sachse. PACMOAA was in support of the six Joint Leadership Council (JLC) initiatives that were forwarded to the 2018 Virginia General Assembly for discussion and hopefully, approval. They are as follows:

- 1.Support of a state-wide real property tax exemption of the principal residence of a surviving spouse of a 100% disabled veteran.
- 2.Support of encrypted electronic ballots for deployed military service members.
- 3.Establish a dedicated source of funding for VECRP
- 4.Provide an income tax subtraction deduction for certain low income 100% disabled veterans
- 5.Change eligibility for higher education benefits under the Virginia Military Survivors and Dependents Education Program (VMSDEP)

6.Support for a change from \$3000 to \$5000 to the state income subtraction level for members of the Virginia National Guard

This year, because of the election turmoil and renovation of the General Assembly Building, there was no "Storming the Hill". As a result, it was next to impossible to schedule PAC-MOAA visits with the General Assembly members. Still, I will be in contact with our General Assembly members for updates on the six aforementioned initiatives.

## NEWS FROM MOAA

### SURVIVING SPOUSE CORNER

In addition to PACMOAA seeking a Surviving Spouse Liaison, MOAA is looking for a new SSAC virtual member. MOAA's Surviving Spouse Advisory Committee (SSAC) now is accepting nominations for its new virtual member position. The SSAC reports to national MOAA's president on issues affecting the surviving spouses of military members. The virtual member position is aimed at surviving spouses who might not be able to travel because of jobs, children, etcetera, but who are interested in working on surviving spouse issues. The virtual member will serve a two-year term beginning in April. The [nomination form](#) and required documents must be submitted by March 31. [Learn more about the SSAC.](#)

The Surviving Spouse Advisory Committee (SSAC) was originally established in 2004 as the Auxiliary Member Advisory Committee (AMAC). The Committee name change to Surviving Spouse Advisory Committee (SSAC) in 2015 was made to more accurately describe the particular membership population segment both MOAA and the Committee serve. However, the mission of the Committee remains the same: to represent the interest of all surviving spouse members, to ensure they

continue to feel a part of our military and MOAAA family, and to raise the awareness of MOAA National as well as Councils and Chapters about the needs and issues of surviving spouses.

The Committee is composed of six surviving spouse members who are appointed for a term of three years. Each year, in February, two of the six rotate off and are replaced by new members. Each Committee Member is assigned an area of the U.S. and works with the Surviving Spouse Liaisons in that area to disperse valuable information and serve as a point of contact for surviving spouses in their Council and Chapters. The Committee convenes twice a year in conjunction with the Board of Directors Meetings in April, and at the Fall Annual Meeting. In addition to the in person meetings, the Committee also meets over a conference call during the July timeframe. The Committee Chair and MOAA Staff Advisor provide direction and report directly to the MOAA President on issues impacting military surviving spouses. This information provides valuable input for our organization's advocacy on Capitol Hill.

### TRICARE AND PHARMACY CHANGES

Normally News from MOAA contains only news from MOAA. However, with recent changes to our healthcare benefits, I felt it necessary to produce this short article sourced from Smallwood, Watson, [Military.com](#), [MOAA](#) plus neighbors and friends.

Point one, "no single source or article can prepare you for the dynamics of these changes. Point two, "locate reliable sources to help you evaluate your particular situation and prepare yourself." Point three, "Remember I am just a newsletter hack. Take what I offer and go to subject matter experts for explanations and advice." Active duty, guard, reservists, retirees, and TFL eligibles all seem to be affected differently. To assist you, I have listed some sources.

Here are some bullets to consider.

There are few changes to TFL that may not really be noticed by most people. Everyone else must evaluate how changes affect them.

This year ONLY there is an extra benefit. Tricare fiscal year start has changed from 1 October to 1 January resulting in a free three month no charge extension of your existing catastrophic cap. To optimize use of this extension schedule medical treatments (i.e. needed PT) to be completed before 1 January. Some Catastrophic caps have increased from \$3,000 to \$3,500.

Congress set 2018 Tricare operation so there will be no switching of benefit programs available outside of open season, except within 90 days of a Qualifying Life Events (QLE). Congress also left Tricare the task to develop a list of valid QLE list. I just reviewed the Tricare [QLE list](#) and found "having a baby." I have heard from reliable sources that "pregnancy" is not on the QLE. The catch may be in the details, the spelling or the list was updated. Be sure to check if this affects you.

As Sherry mentioned in her page one article, the Delta Dental retiree program ends this year. If you are interested in the new Federal Employee Dental and Vision Insurance Program (FEDVIP), you will have to do some [shopping](#). There about ten programs available to sign up for during open season this Fall. If you are currently using Delta Dental and sat-

isfied, you MUST APPLY for their new product during the upcoming Fall open season or you will be without insurance and not able to get it again until the next open season.

Although I am unsure how this affects Tricare policy choices, I have experienced restricted access to Medical Treatment Facilities Specialties as a retiree. As budgets tighten, I can envision restrictions to access becoming an increasing problem.

We will, if not already, experience changes in pharmacy benefits. MTF pharmacies will still provide no cost prescriptions but local formularies will shrink. This means we will have to use Express Scripts or a local pharmacy that accepts Tricare for those drugs.

Co-pays have gone up. A 90-day supply of generic drugs received through Express Scripts mail-order pharmacy went from free to \$7. Co-pays on brand-name drugs received through the mail went from \$20 to \$24 and from \$49 to \$53 for non-formulary drugs.

Co-pays for prescriptions filled at in-net retail pharmacies have gone up. A 30-day supply for generic drugs increased from \$10 to \$11, while brand-name drugs went from \$24 to \$28; non-formulary drugs went from \$49 to \$53. Actually, this increase was not a result of recent Tricare changes. Congress had a temporary ongoing semi-fix to the widow's tax in the NDAA that expired this year. Facing the task of finding a humongous amount of money to make a permanent fix, Congress opted to fund a fix by increasing pharmacy co-pays. [MOAA is always fighting to eliminate the unfair widow's tax.](#)
