ORDER EXTENDING CLAIM FILING DEADLINE

This matter having come before the Court by motion of the Commissioner of the Vermont Department of Financial Regulation in his capacity as Liquidator (“Liquidator”) of Elite Transportation Risk Retention Group, Inc. (“ETRRG”), for an order extending the claim filing deadline established in this proceeding pursuant to 8 V.S.A. § 7061(b), it is ORDERED that:

1. The Liquidator’s Motion to Extend Claim Filing Deadline is APPROVED;
2. The claim filing deadline originally established by the Liquidator (May 15, 2019) is extended such that all claims against ETRRG must be filed with the Liquidator no later than November 15, 2019; and,
3. The Liquidator shall post notice of this Order on ETRRG’s website and provide notice by e-mail or mail to ETRRG’s member policyholders.
