 - b. Condition of supplies (i.e. sealed cases vs. loose items, etc)
 - c. Quantities on hand
 - d. Most importantly, expiration dates
- 2. We send you a proposal/purchase order within 72 hours of receiving your list
- 3. Once the proposal is <u>accepted</u>, <u>please email (or fax if needed) the signed Purchase Order</u> and Bill of Sale
- 4. <u>We will send a FedEx call tag</u> so the supplies can be shipped out us, at no cost to you. If the shipment is at least one pallet we will arrange and pay for freight
- 5. Our payment terms are <u>net30</u> from when we receive the supplies
- 6. Once we receive the supplies, all liability is transferred to WestCMR.
