HOUSING PARTNERSHIP FOR THE NEW RIVER VALLEY Minutes from 9/28/98 Meeting After the initial welcome to all members, Pat Brown asked the members to introduce themselves and theagencies they represent. The Housing Partnership continues to be made up of a diverse group of individuals/agencies who share a common interest in providing housing for the low-income in the New River Valley. Committee Reports Mary Hall gave a brief report on the status of the Planning Grant. The Town of Narrows was awarded a Community Improvement Grant in the amount of \$14,260. As part o that grant, a (housing) needs assessment will be conducted. In the coming days, a survey will be mailed to a number of individuals/agencies who serve the low-income. Please take the time to complete the survey and return it to Ms. Hall within the required time period. In addition, a Continuum of Care Plan is being developped. The Continuum of Care will be an essential component of the planning grant; and it will eventually assist other agencies, such as the Women's Resource Center and and the New River Valley Shelter in securing funding in the future. A needs assessment is part of the Continuum of Care, but it is not necessary to duplicate efforts. So, only one needs assessment will be conducted. The Continuum of Care Committee will be composed of a small core group. Ann Angert spoke on the progress of the site committee. Several possible sites for the transitional housing were being explored at this time. Anyone interested in serving on this committee should contact Ms. Angert. A time line was given out regarding the planning grant--from its inception to its estimated completion on March 26, 1999. Although March seems many months away, it is important that work be on-going in all committees if the Housing Partnership is to meet the March deadline. Pat Brown stated that the Continuum of Care Comittee will have its third meeting on November 9th at 2:00pm. The tenantive meeting place will be the WRC Administrative Office, but Pat will confirm the exact location at a later date. The Housing Partnership then diverged from its meeting and became a work session for the Continuum of Care. Work Session Pat Brown explained the goal of the Continuum of Care, as well as its itention-to write a Continuum of Care Plan. Again, the needs assessment will become part of the Continuum of Care. The needs assessment will be conducted by Mary Hall. 1. Defining Homelessnes in the New River Valley The Housing Partnership was asked to identify the homeless in the New River Valley. It quickly became apparent that homelessness has many faces. °Chronically mentally ill/substance abusers °Elderly

°Disabled/Chronically III, including HIV positive

°Life skills counseling--On-site at WRC for victims of domestic violence, on-site in Montgomery and Giles

Short-term financial assistance—New River Community Action; Homeless Intervention Program

<u>Money to clear minor credit problems</u>—Depts. of Social Services

\*Affordable housing--Homeownership--Habitat for Humanity, VMH, Inc., Rural Redevelopment Authority

--Rental--Project-based Section 8, tenant-based Section 8, Rural Redevelopment Authority

°Transportation--Two Town Trolley, Blacksburg Transit, some cab service

<u>Child Care</u>—WRC, Depts. of Social Services

"Homeownership Counseling --VMH, Inc., Giles County Housing and Development

°Health Care--Free Clinic, Medicaid

Food, clothing, household goods, applicance banks -- New River Community Action

°Job skills/training--JTPA, public schools, community college

Clearly, this list is not exhaustive, nor does it highlight constributions made through the private sector, particularly churches in the New River Valley. Yet while these services do exist in the New River Valley, the large number of clients seen puts a burden on all agencies. Money is quicly used.

#### 3. Gaps in service

Finally, the Housing Partnership identified the most apparent gaps in existing service.

°Transitional housing with on-site services

°Additional emergency shelter appropriate to situation, such as a shelter for teens


\*Central location for disemminating information/making referrals

°Emergency assistance, such as money for rent, security deposits, etc.

°Transportation

°More child care, particularly for off hours, weekends

The Housing Partnership felt these six gaps in service were the most critical in the New river Valley, with transitional housing and additional emergency shelter as probably the two most important.

Pat Brown welcomed everyone to the meeting and called it to order. As always, those members present introduced themselves and the organizations/agencies they represent.

Mary Hall gave an update on the grant and the development of transitional housing in the New River Valley.

<u>Needs Assessment</u>—The needs assessment is currently underway. Any person/agency which has not yet responded should do so as soon as possible. The information provided thus far has been very useful.

Site Selection—The Site Selection Committe has been looking at potential sites. It is felt that Christiansburg (Montgomery County) will be the location because of its access to a wide array of services, as well as (some) public transportation. The Site Selection Committe has also been studying the feasability of building (new consturction) the transitional housing units, rather than rehabing an existing structure. Rehabilitation of a building involves much more than just remodeling. For example, the Housing Partnership cannot displace people in order to create transitional housing.

The process of selecting a site is on-going. Factors which will be considered include: services, access to public transporation, education/job training, potential jobs, shopping and overall environment. In additional, there are political considerations, especially which localities would support and welcome transitional housing units within its community.

It is felt that ten to twelve units should be developed. These apartments would have a mix of one-, two- and three-bedrooms. The needs assessment will have an impact on this final decision.

Interviewing Potential Engerineering Firms—While there has been some initial inquiry, there are other concerns which need to be addressed first. Specifically, the transitional housing units must have on-going funding if the program is to continue. In addition, there must be both property management/maintenance and on-site or contractual services. All of this requires money—probably in excess of \$40,000 per year. To date, there is no real plan for on-going funding of the transitional housing units. Mary Hall and Nancy Rader will be exploring potential funding through various agencies, such as DHCD, VHDA and RRD. FEMAN and per-bed funding are also possible sources.

Discussion followed as to what agency might manage the transitional housing units, such as New River Family Shelter, Women's Resource Center, New River Community Action or Giles County Housing and Development. Pat Brown expressed concern that this would be a very large undertaking for whom ever managed the units. She stated that she felt that the Women's Resource Center should remain with its purpose—domestic violence. While many homeless individuals/families are indeed victims of domestic violence, that the transitional housing units will probably not serve just victims of domestic violence. Perhaps the management and services needed for these units will be be out of the scope of any current agency, but without more information

on on-going funding, it is difficult for these decisions to be made.

Once more information is gathered, Mary Hall will send out RFPs regarding the maangment and services for the transitional housing units. Mary Hall also expressed concern that she may need to ask for an extension for the grant, as further work is needed on these issues.

A brief discussion was held regarding what format the Continuum of Care should take. There was discussion as to whether or not services should be listed under localities or under types of services, i.e., housing. In addition, the Continuum of Care should indicate the steps that a person should follow as he/she moves from homelessness to some level of self-sufficiency. Areas to be addressed include: housing, public transportation, services, education/job training, etc.

Anyone interested in assisting in the writing of the Continuum of Care should contact Pat Brown.

The next meeting for the Housing Partnership of the New River Valley has been set for January 19, 1999 at 2:00pm at the Administrative Offices of the Women's Resource Center.

January 19, 1999

I. The Housing Partnership for the New River Valley (Partnership) met on Tuesday, January 19, 1999 from 2:00 to 4:00 p.m. Pat Brown called the meeting to order, introductions were made, and a summary of this organization's work to date was delivered. Attendance list attached.

II. The first order of business was Bob Rogers' (ARCHITECTURAL ALTERNATIVES) presentation of his firm's findings/recommendations surrounding the properties under consideration as potential sites for Transitional Living Units as selected by the Transitional Housing Sub-Committee. Of the sites reviews in Radford and Montgomery County, the Grove/Downey/Fifth properties in Radford were selected as the most appropriate to date. (Selection of a site must be completed prior to writing the \$750,000 grant proposal for construction/renovation.) The Sub-Committee has targeted victims of Domestic Violence at this time for transitional housing and support services. The Women's Resource Center of the New River Valley (WRC) would manage the housing units. We would seek VHDA Housing Certificates to come directly to the WRC to defray some of the costs associated with such housing (rent/utilities). WRC would hire 1.5 to 2 persons to administer services/management to the Transitional Housing residents. Therefore, the WRC would also seek a grant to cover the balance of costs initially via a supportive housing grant. In addition to regular meeting by the Transitional Housing Sub-Committee, Bob Roger, Pat Brown, Mary Hall, and several other committee members plan to meet with the City of Radford to determine what, if any, specific ordinances related to the development of property in Radford exist. This Sub-Committee's next meeting date is January 29, 1:00 p.m., at the WRC.

III. Next on the agenda was Pat Brown's update to the Partnership of the work the Continuum-of-Care Sub-Committee has accomplished thus far. To precipitate further progress in this vast document, existing Emergency Assistance for the homeless was discussed. Amanda Griffeth of the New River Family Shelter (NRFS) gave an update about her organization. In summary, the NRFS is has been undergoing a transition of its own. They currently provide no emergency housing due to renovation of their site. However, they do have up to about \$300 per family available to New River Valley residents to assist with homeless emergencies (such as paying deposits). [Professionals are to call "Shelley" at (540) 961-5520 to access this money.] There are no clear guidelines on the use of this money at this time, but Amanda reported that the NRFS Board will take action on this issue at tonight's meeting.

Pat mapped out some of the Continuum-of-Care resources for the homeless by County. This work took considerable time and precipitated lively discussion by the group.

IV. The next order of business was to pass motions concerning The Partnership's desire to proceed with the work of the Sub-Committees as reported on this date.

Motion 1: Ann Angert moved that the Housing Partnership for the New River Valley approve the site for Transitional Housing in the City of Radford and that the Partnership empower the Transitional Housing Sub-Committee to select the final site and present the information to the Radford City Council for approval. This motion was seconded by Nancy Rader. The Partnership voted unanimously to pass this motion.

Motion 2: Amanda Griffeth moved that the Housing Partnership for the New River Valley formally approve the selection of the Women's Resource Center of the New River Valley to own and operate the Transitional Housing Units this organization is seeking to provide. This motion was seconded by Mary Beth Pulsifer. The Partnership voted unanimously to pass this motion.

V. The Partnerships next meeting date is February 25, 2-4 p.m. at the WRC. Meeting was adjourned at 4:00 p.m. by unanimous vote.
