## LOML Impressions Agreement

It is understood that all images and/or video footage taken by LOML Impressions remain the property of the videographers and may be used for our advertising, marketing or social media purposes.

Copyright Law: The copyright of the video remains with the Videographer. The Videographer grants the Clients permission to share the footage under the following conditions. The video taken by the Videographer is for personal use by the Clients and their friends and relatives. Sale, Publication or any Commercial use of the footage is not allowed without prior written permission from the Videographer.

**The clients cooperation during the shoot is required in order to obtain desired shots. Failure to cooperate may result in missed or undesirable footage.**

Model Release: The Clients grant the Videographer and its legal representatives, heirs and assigns, the irrevocable and unlimited consent to use the footage of the Clients for editorial, competition, advertising and any other purpose and in any manner; to alter the video without restriction; and to copyright the footage. The Clients hereby release the Videographer and its legal representatives, heirs and assigns from all liability and claims in connection with the footage.

**It is the client's responsibility to notify us of any changes in times or locations no later than 48 hours before the event.**

**It is not our responsibility to secure permission from your venues to photograph or take video of your wedding. Please make sure it will not be an issue in advance.**

**It is understood that there may be circumstances beyond LOML Impressions control and we are not held responsible for issues that may arise during time of event (ie power failure, equipment malfunction, missing shots due to guest walking in front of the shot).**

Limit of Liability: If a videographer is too ill or becomes injured and cannot supply the wedding services specified above the Videographer will try to book a replacement wedding videographer. Under normal circumstances a second videographer from LOML Impressions is there for the day anyway and this videographer will then shoot the day on his/her own. If both videographers are unavailable and a replacement videographer cannot be found then liability is limited to a refund of any payments received.

The Videographers have working methods in place to prevent loss or damage to your footage. However, there is the unlikely possibility that images may be lost, stolen or destroyed for reasons in or beyond our control. In these circumstances liability is limited to the return of fees paid for the service or part thereof according to the percentage of video supplied.
