The Executive Committee met on May 28, 2020 to discuss the potential start of the 2020 baseball season. The committee has also set the date for the **Summer Business Meeting – June 28, 2020 starting at 6:00 PM.** In compliance with the COVID-19 guidelines put out by Governor Mills and the Maine CDC, effective June 1, 2020, gatherings are permitted but limited to 50 people. Since the meeting has the potential to exceed 50 members, the Executive Committee as decided this meeting will again be done through ZOOM.

Single Umpire Mechanics

During the Summer Business Meeting (June 28, 2020) the mechanics and guidance for single umpire (working from behind the pitcher) will be discussed. *All members that wish to be assigned games while under the COVID-19 period should attend however the is **NOT** a mandatory requirement.*

Assigner's Corner

All members are reminded to block out days on Arbiter for dates you are unavailable. During this COVID-19 period, it would be extremely helpful if you would shoot Duke an [email](#) indicating you do not wish to be scheduled for game assignments. If you do this, you will not have to update your availability on Arbiter.

*Reminder: All WMBUA umpires may at their choosing elect to **NOT** umpire during the 2020 summer season in-part or throughout without penalty or prejudices.*

WMBUA COVID-19 Supplemental Rules & Guidance

- (1) All WMBUA umpires may at their choosing elect to **NOT** umpire during the 2020 season in-part or throughout without penalty or prejudices.
 - a. Further, WMBUA umpires may at any time ask to be removed from their assignment again without penalty or prejudices.
 - i. WMBUA umpire should NOT officiate any game(s) if feeling ill or have a fever
- (2) All summer league games with WMBUA will consist of ONE umpire who will position themselves at an appropriate distance **BEHIND** the pitcher
- (3) WMBUA umpires while in the infield shall wear a solid dark mask covering nose and mouth.
 - a. During between inning warmups the umpire should move to the sidelines in foul territory and may remove their mask providing social distancing is possible,
 - b. It is recommended that hand sanitizer be used for pre-cautionary measures between innings.
 - c. Any discussion between umpire and coach shall be done with no less than a 10-foot separation.
- (4) WMBUA umpire will at no time handle a baseball.
 - a. The defensive team is always required to supply their pitcher with a legal and sanitized baseball,
 - b. The umpire shall at any time be permitted to request from the defensive team a replacement ball should it become necessary because of suspected damage (i.e. foul ball hitting the dugout or backstop) or several players handled the ball in the act of a play.
- (5) Game Fee for the **2020 summer baseball** season were modified as follows:
 - a. Youth leagues - \$100/7 inning & \$90/6 inning
 - b. College leagues - \$125.00/9 inning & \$100.00/7 inning
 - c. Men's leagues - \$100/game
 - d. The fee penalties for game cancellations are waived
- (6) Fingerprinting requirement is in effect. Any WMBUA member that has not complied with the Executive Committee rule will not be eligible for game assignments

Fingerprinting

Before the COVID-19 pandemic, all members should have at a minimum started the process for fingerprinting. You have had over a year to have this requirement completed.

If you have started the process, you should have received acknowledgement that DOE has accepted your application and you have paid the \$15.00 application fee and/or you received confirmation that you paid the \$55.00 fingerprinting fee.

Due to COVID-19, the Executive Board approved a modification to this year's requirement. If you can show proof of one of the following, you will be assigned games:

- (1) Proof of payment (\$15.00) from Department of Education (DOE) – Application Fee
- (2) Proof of payment (\$55.00) from Department of Public Safety – Fingerprinting Fee
- (3) Proof of IdentoGO Registration
- (4) Proof of IdentoGo Fingerprinting Appointment

COVID-19 Guidance/Reference Information

WMBUA Insurance Agent - K&K recommends following The Center for Disease Control (CDC) Key Concepts for managing COVID-19:

- **Minimize the chance of exposure.** The most common way to catch the virus that causes COVID-19 is from close contact with other people.
