

under and in accordance with the provisions of Act of the Philippine Commission Numbered Fourteen hundred and fifty-nine, enacted March first, Nineteen hundred and six, as amended by Acts of the Philippine Legislature, Numbered Fifteen hundred and six, Fifteen hundred and sixty-five, Sixteen hundred and thirty, Seventeen hundred and forty-four, Eighteen hundred and thirty-four, Eighteen hundred and ninety-five, Twenty hundred and three, Twenty hundred and twelve, Twenty hundred and thirty-seven, Twenty hundred and ninety-two, Twenty-one hundred, Twenty-one hundred and thirty-five; Twenty-four hundred and fifty-two, Twenty-seven hundred and twenty-eight, Twenty-seven hundred and ninety-two, Twenty-nine hundred, Twenty-nine hundred and ninety-four, Thirty-five hundred and eighteen, Thirty-six hundred and ten, Thirty-seven hundred and forty-one, Thirty-eight hundred and forty-nine and Thirty-eight hundred and fifty, and Commonwealth Acts Numbered Two hundred and eighty-seven, and Four hundred and thirty-seven, were presented for filing in this Commission on

REVISED ARTICLES OF INCORPORATION

OF

Oct 22

"MANILA TEACHERS' MUTUAL A&P SYSTEM, INCORPORATED"

FROM ALL BLD BY THIS & PRESENTS:

That we, all of whom are of legal age, residents ~~and citizens~~ of the Philippines, have this day voluntarily associated together for the purpose of forming an association under the laws of the Philippines.

AND WE HEREBY CERTIFY:

FIRST: That the name of the association shall be the

"MANILA TEACHERS' MUTUAL A&P SYSTEM, INCORPORATED."

(Formerly, Manila Teachers' Mutual Death Aid System, Inc.) as amended on Jan. 28, 1970
& COND. That the purposes for which this Association is formed are: ~~are~~ ^{are}:

- a. To foster brotherhood and mutual help and benefit among the members of the Association;
- b. To encourage the habit of thrift and saving among the members of the Association; and
- c. To provide financial assistance to beneficiary or beneficiaries of deceased members in the amount of Two Thousand Pesos (\$2,000.00) upon the death of a member.

INCIDENTALLY:

- d. To acquire real or personal property necessary for its operations;
- e. To issue membership certificates; and
- f. To possess and enjoy all the powers and privileges under the law of the Republic of the Philippines for the attainment of the above purposes of the Association; provided, however, that the funds of the Association shall not be spent except in accordance with law and as so roved by the Board of Directors thereof.

SECOND: That the place where the principal office of the Association is to be established or located is 91-6 General Luna St., Malabon, Rizal, Philippines.

THIRD: That the term for which said Association is to exist is fifty (50) years from and after the date of incorporation.
