1. Setup/ Break Down: All Exhibitors must be set up and ready to sell by 1:00 pm the day of Fostering Fun Ride. Exhibitors may begin setting up at 11:00 am the day of Fostering Fun Ride. Break down can start no sooner than 7:00 pm on and must be completed by 9:00 pm. No vendor is to close before the official closing time. Sellers are responsible for their selling spaces. \*Before leaving, be sure your area is clean and trash-free.
2. Staffing: Exhibitor tables/ booths must be manned at all times and intact until post ride event closes at 7 p.m. Kindred Heart Families, Inc. is not responsible for merchandise or display materials.
3. Exhibitor Items: Kindred Heart Families, Inc. reserves the right to have items removed that are considered not appropriate. No open flames, selling of food, profanity, tobacco or alcoholic items/references, or suggestive material are permitted.
4. Exhibitor Responsibility: Exhibitor will be fully responsible for any loss or damage to his or her property by theft, fire or casualty. Kindred Heart Families, Inc. and the Town of Sheboygan expressly disclaims any responsibility for same. Exhibitors shall be responsible for any damage which may be incurred to the facilities as a result of or in connection with its operation.
