1. management, officials and volunteers assisting in the event, the sanctioning organization or any subdivision thereof, grounds operators, grounds owner, officials, promoters, sponsors, advertisers; all of the purpose herein referred to as "releases" from all liability to the undersigned, their personal representatives, assigns, heirs, and the next of kin for any and all loss or damage, and any claim or demands therefore on releases or otherwise while the undersigned is participating in the event.

2.
