ACKNOWLEDGEMENT OF RISKS

I (We) recognize the element of risk in any adventure, sport, or activity associated with the outdoors. I (We) am (are) fully aware of the risks and dangers inherent in Double Spur Outfitters LLC activities such as, but not limited to:

1. Risks and dangers of bodily injury, including permanent disability, paralysis, and possible death.
2. That certain activities will be conducted over public roads, trails, and land open to the public during the activities and upon which the hazards of traveling are to be expected.
3. These risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the activity, non-participants traveling or using the public facilities, roads, or trails, or the conditions in which the activity takes place.
4. There may be other risks or dangers and social and economic losses either not known to me or not readily foreseeable at this time.

Knowing the risks and dangers, I (we) understand the possible consequences of participating in such activities are as follows:

1. Bodily injury, including permanent disability, paralysis, and possible death.
2. Social and economic losses, such as damage or destruction of personal property of mine (ours) or the property of others.

I (We) certify that I (We) have the necessary skills and ability to participate in the said activities and assume full responsibility for myself (ourselves) for bodily injury, death, and loss of personal property, and expenses thereof as a result of my (our) negligence, gross negligence, or misconduct in participating in said activities except to the extent such damages or injuries may be due to the negligence of Double Spur Outfitters.

I (We) also agree to abide by the rules or instructions given to me (us) either verbally or in writing by Double Spur Outfitters, LLC, its employees, guides, agents, and/or independent contractors.

I (We) further understand that Double Spur Outfitters, LLC reserves the right to refuse to allow the participation of any person or persons who it, in its sole discretion, judges to be incapable of meeting the rigors and requirements of participating in said activities.

I (We) have read, understood, and accept the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon me (us) during the entire period of participation in the said activities. My (Our) participation in these activities is purely voluntary, and I (We) elect to participate in spite of the risks. I (We) assume the risk of such activities and indemnity and hold Double Spur Outfitters, LLC, its principals, employees, and contractors harmless for damages (economic or non-economic) resulting from and/or occurring as a consequence of said activities.

In the event that I (We) file a lawsuit against Double Spur Outfitters, LLC, its principals, employees, agents, or contractors, I (We) agree to do so solely in the Commonwealth of Virginia, and I (We) further agree that the substantive law of the State of Virginia shall apply in any action filed in Court without regard to the conflict of law rules of any state. I (We) understand that I (we) can only waive liability to the extent that The Commonwealth of Virginia State law will allow. I (We) agree that if a portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
