AMENDED ARTICLES OF INCORPORATION

OF

MT.-PROVINCE TEACHERS' MUTUAL AID SYSTEM, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock and non-profit association under the laws of the Republic of the Philippines.

THAT WE HEREBY CERTIFY:

FIRST:

The name of the said association shall be:

MT-PROVINCE TEACHERS' MUTUAL AID SYSTEM, INC.

SECOND: That the purpose or purposes for which such association is incorporated are:

- (a.) To foster brotherhood and mutual help among its members;
- (b.) To encourage the habit of thrift and savings among its members;
- (c.) As a mutual aid association, to provide for the payment of life, sickness, accident or other benefits exclusively to the members of the association. (As amended on May 14, 2016)

And, incidentally:

To possess and enjoy all the power and privileges under the law for the attainment of the above purposes, provided that any profit which may be obtain as an incident to its operations shall, whenever necessary or proper, be used in furtherance of its purpose or purposes.

THIRD: That the place where the principal office of the association is to be established is at:

FOURTH: That the term for which the association is to exist is fifty (50) years from and after the date of issuance of the certificate of incorporation.

EIGHTH: That no part of the income which the association may obtain as an incident to its operation shall be distributed as dividends to its members, trustees or officers subject to the provisions of the Corporation Code on dissolution. Any profit obtained by the association as a result of its operation, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II, subject to the provision of Title XI of the Corporation Code of the Philippines.

NINTH: That <u>HELEN L. JOVEN</u> has been elected by the members as Treasurer of the association to act as such until his/her successor is duly elected and qualified in accordance with the by-laws; and that as such Treasurer, he/she has been authorized to receive for and in the name and for the benefit of the association all contributions or donations paid or given by the members.

TENTH: That the incorporators undertake to change the name of the corporation immediately upon receipt of notice or directive from the Securities and Exchange Commission that another corporation, partnership or person has acquired a prior right to the use of that name or that the name has been declared as misleading, deceptive, confusingly similar to a registered name, or contrary to public morals, good customs or public policy.
