Jordan Krahenbuhl, Clark County Building Department, will talk on minimizing water heater scald hazards.

154 °F / 68 °C Scald Injury - Immediate

149 °F / 65 °C Scald Injury - 1 second

140 °F / 60 °C Scald Injury - 2 seconds

131 °F / 55 °C Scald Injury - 5 seconds

126 °F / 52 °C Scald Injury - 30 seconds

122 °F / 50 °C Scald Injury - 1 minute

120 °F / 49 °C Scald Injury - 3 minutes

116 °F / 47 °C Scald Injury - 35 minutes

110 °F / 43 °C Shower Temperature Maximum misconception that the water heater thermostatic control is capable of delivering a consistent and safe water temperature without further temperaturecontrol downstream of the water heater outlet.
